ORDINANCE
Acct. No. 13836 - 1
Permit No. 1089259

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to NEWARK CORPORATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed a portion of the public right-of-way adjacent to its premises known as 4809 N. Ravenswood Avenue to be used for employee parking. Said use of the public way shall provide diagonal spaces for one hundred sixteen (116) cars with parking on the east and west side of North Ravenswood Avenue as follows:

East

Shall start from a point on the north side of West Lawrence Avenue and shall run north on North Ravenswood Avenue for a distance of three hundred twenty-six (326) feet at a width of eighteen (18) feet.

West

Shall start from a point on the north side of West Lawrence Avenue and shall run north on North Ravenswood Avenue for a distance of eight hundred ninety-seven (897) feet at a width of eighteen (18) feet.

The location of said privilege shall be as shown on prints hereto attached, which by reference are hereby incorporated and made a part of this ordinance.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-075 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1089259 herein granted the sum of one thousand seven hundred seventy-eight (\$10,778.00) per annum in advance.

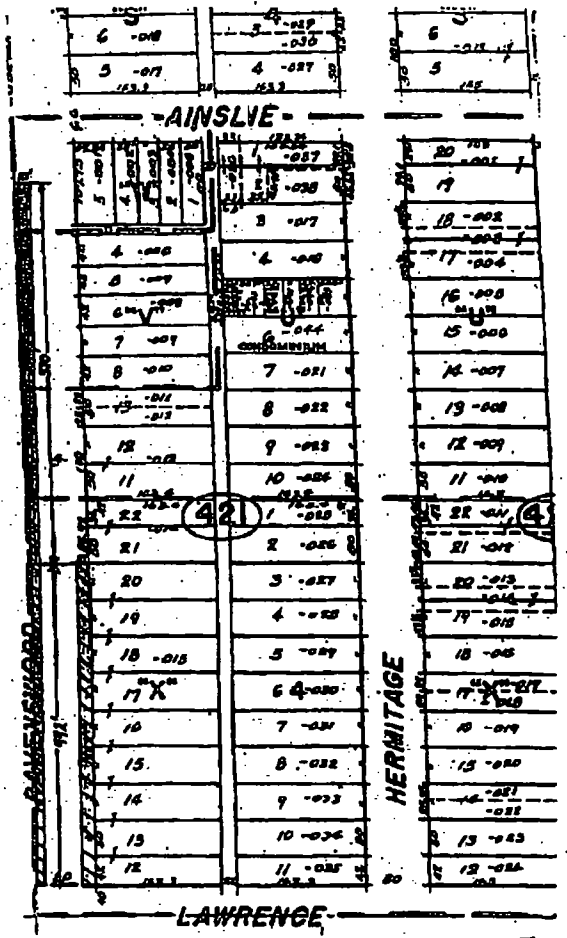
A 25% penalty will be added for payments received after due date.
