BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 7-G in area bound by

North Wilton Avenue, a line 239 feet South of and parallel to Diversey Parkway, the alley next East of and parallel to North Wilton Avenue, a line 267 feet South of and parallel to Diversey Parkway

to those of a RM4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.




The undersigned, Thomas S. Moore, being first duly swom on oath, deposes and says the following:




The applicant Condominium Association seeks to correct a zoning problem created by the building being over built before the present owners bought their units. The floor area of the building exceeds that allowed in an RT4 Zoning District, but would conform to the floor area allowed in an RM 4.5 District.
