ORDINANCE

Club Pilates River North

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to Club Pilates River North upon the terms and subject to the conditions of this ordinance to maintain and use one (1) Sign(s) projecting over the public right-of-way attached to its premises known as 165 W SUPERIOR ST.

Said Sign structure(s) measures as follows along W. Superior Street:

One (1) at two (2) feet in length, two (2) feet in height and eleven (11) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1555127 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.






1. Sign to be 24" x 24" located 4' from the back veneer face and signed with the dimensions of entry to maintain the consistency of all other signs
2. Sign to be converted to back veneer and 25 x 12 1/2" plates
3. Main entrance doors and windows shall have minimum yield strength of 60 ksi
4. Sign is less than 30 pounds
5. Refer to IFA Drawing No. S-101 Rev 3 Dated 11/16/20 for mounting plate attached to the building
