SECTION 1: That the Chicago Zoning Ordinance be amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 2-I in area bounded by:

A line 477 feet west of and parallel to South California Avenue, the alley next north of and parallel to West Taylor Street; a line 237 feet west of and parallel to South California Avenue; West Taylor Street

to those of C1-2 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from after its passage and due publication.

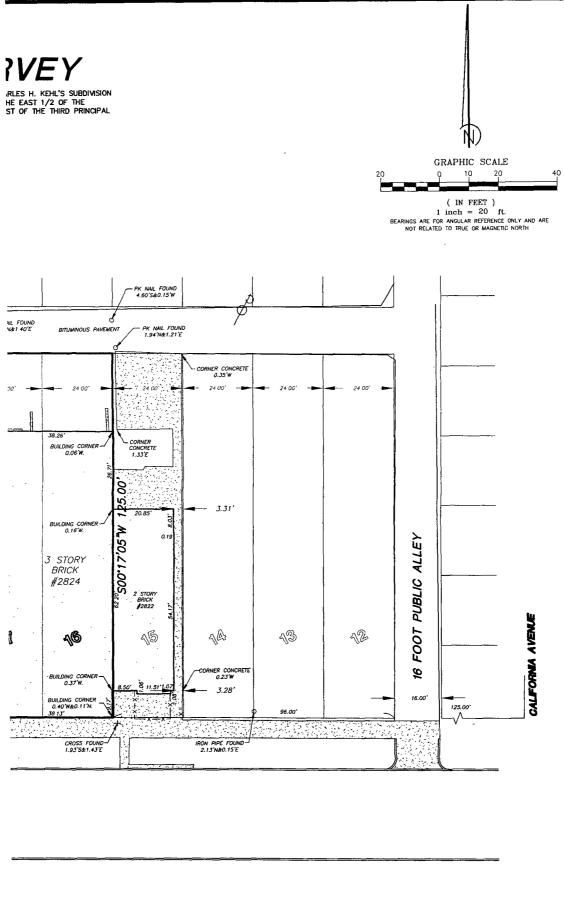
