## ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current RS2 Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 22-B in the area bounded by:

a line 81 feet north of and parallel to East 91<sup>st</sup> Street; a line 76.69 feet west of and parallel to South Brandon Avenue; a line 52.5 feet north of and parallel to East 91<sup>st</sup> Street; South Brandon Avenue; East 91<sup>st</sup> Street; and a line 130 feet west of and parallel to South Brandon Avenue

to those of a B1-1 Neighborhood Shopping District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.


a line 81 feet north of and parallel to East 91<sup>st</sup> Street; a line 76.69 feet west of and parallel to South Brandon Avenue; a line 52.5 feet north of and parallel to East 91<sup>st</sup> Street; South Brandon Avenue; East 91<sup>st</sup> Street; and a line 130 feet west of and parallel to South Brandon Avenue

(hereafter the "Property") will be filed on or about July 18, 2012 with the Department of Housing and Economic Development, City of Chicago by Claretians, Inc., 205 W.
