To those of an B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

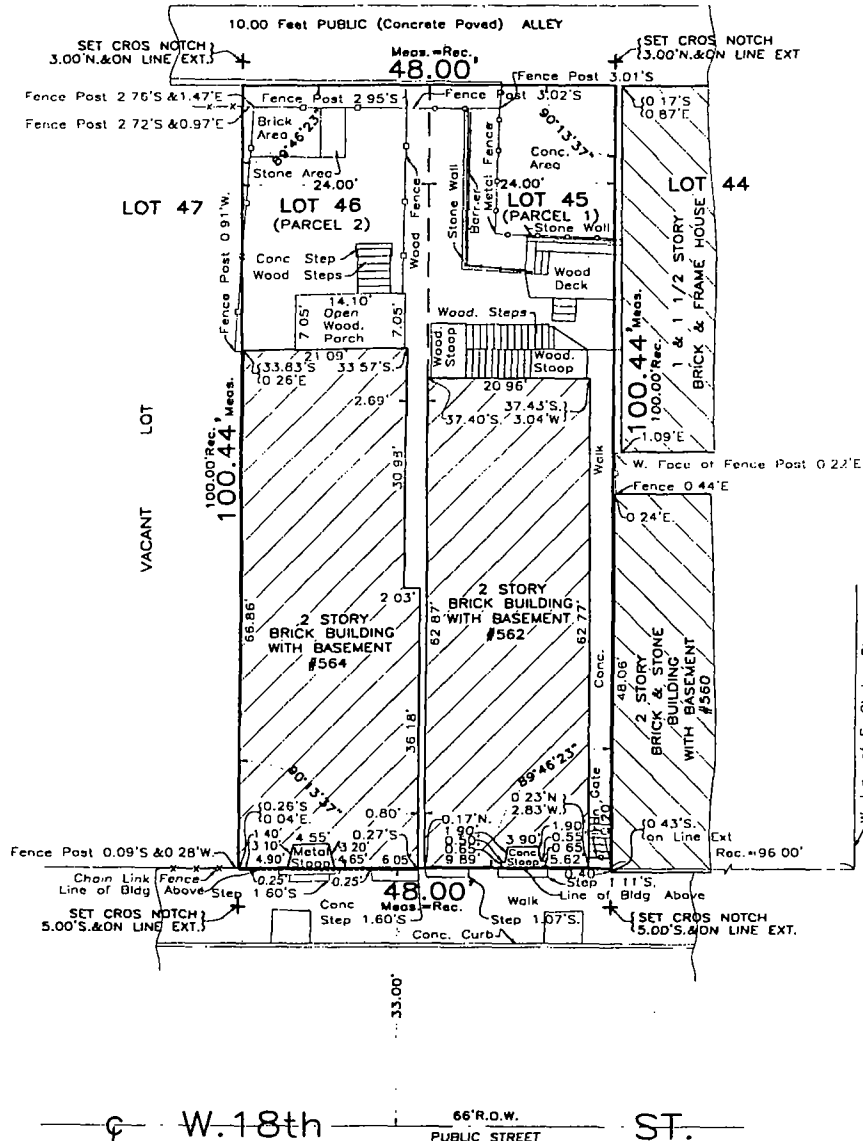
