ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/ Business District symbols and indications as shown on Map No. 20-C in the area bounded by:

At the intersection of 8500 block of South Paxton and the 8500 block of South South Chicago Avenue on southeasterly running line 340.91 feet; then by the adjoining vacant lot at 8534 South South Chicago Avenue on a line 130 feet running southwesterly to the public alley that is parallel to South South Chicago; then by the public alley on a line 216.20 feet running northwesterly to the 8500 block of South Paxton Avenue; then on a line 179.60 feet running northly to the intersection of 8500 block of South Paxton and the 8500 block of South South Chicago,

to those of a M2-2 Light Industry District.

SECTION 2. This ordinance takes effect after its passage and approval.

Applicant will build a new building 22 feet height, 81 feet wide and 219.8 feet long for a total of 17,913 square feet. Site includes 34 parking spacing. The applicant also owns 8501-25 S. South Chicago which is directly across the street and this lot will be used for off-site parking of 82 cars. The building will use for the growing and processing of cannabis and office space. The building will have a loading dock area, meeting space and storage space. No residential use will be involved
