ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3 Light Industry District symbols and indications as shown on Map No. 7-I in the area bounded by:

A line 332.61 feet north of and parallel to West Wellington Avenue; a line 150 feet east of and parallel to North Rockwell Street; a line 150 feet north of and parallel to West Wellington Avenue; and North Rockwell Street;

to those of a C3-3 Commercial, Manufacturing and Employment District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about **December 6, 2016**, I, the undersigned, will file an application for a change in zoning from a M2-3 Light Industry Manufacturing District to a C3-3 Commercial, Manufacturing and Employment District on behalf of Rockwell Properties LLC.

The applicant seeks a zoning amendment to a C3-3 Commercial, Manufacturing and Employment District in order to allow the following businesses at addresses 3017, 3027 and 3031 N. Rockwell:

The applicant intends to use **3017 N. Rockwell** to allow an animal services (canine boarding and training) facility in the rear portion of an existing 1-story building utilizing approximately 5,652 square feet. There is a driveway and no existing parking. At the front of the building is a loading dock which is in use for and connects to the adjacent north business, the address of 3027 N. Rockwell.

3027 N. Rockwell has approximately 11,221 square feet in use for an industrial packaging business. 3027 N. Rockwell is an existing 1-story building.






