

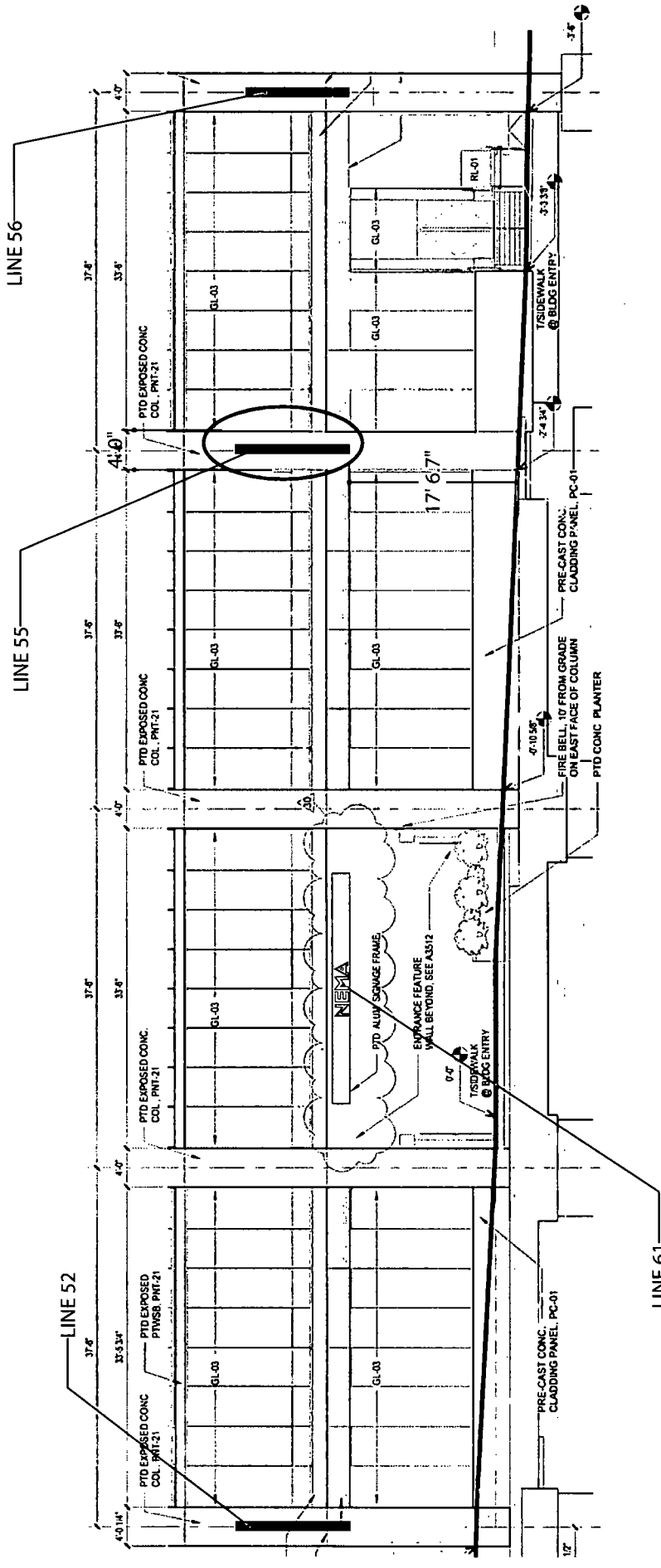

**PARTIAL BUILDING ELEVATION - BUILDING ENTRANCE ALONG E. ROOSEVELT RD.**

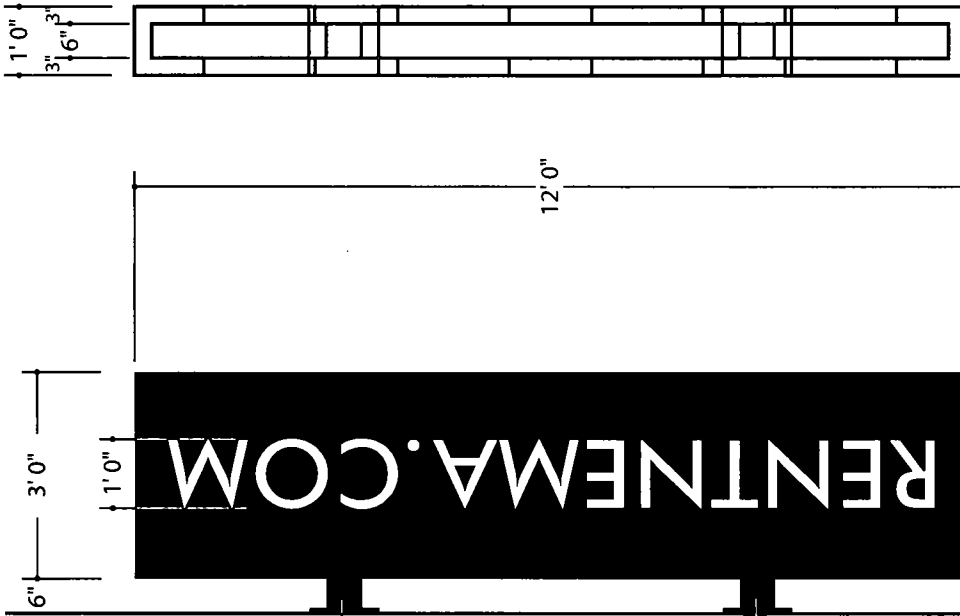

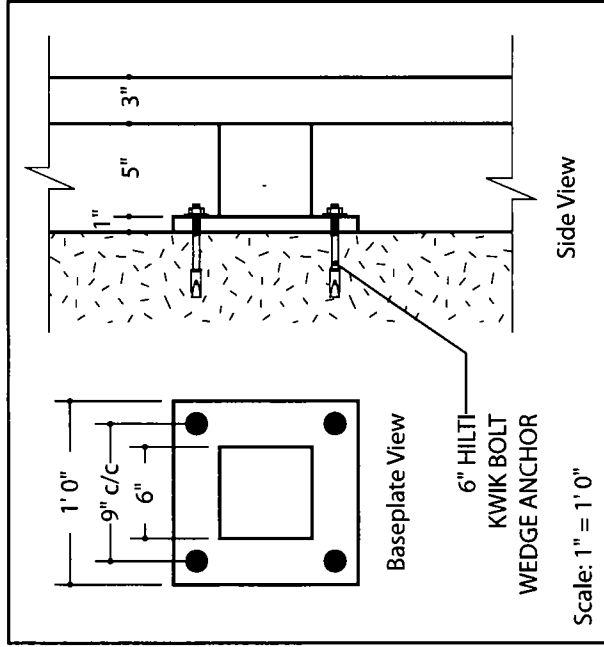
- POWER SUPPLY IN TRANSFORMER BOX

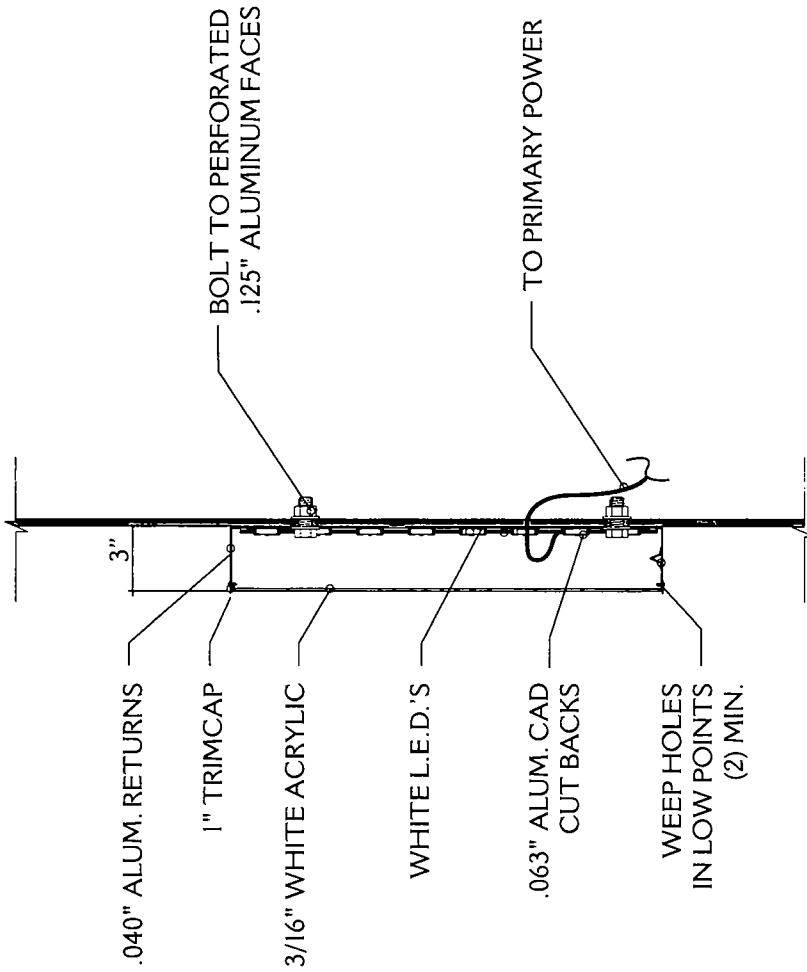
- Steel angle frame
- .080" aluminum skin
- White day / white night channel letters, 3" deep
- 6" square support tubes and 12" square baseplates
- Weld support tubes to steel angle frame so light is not obstructed

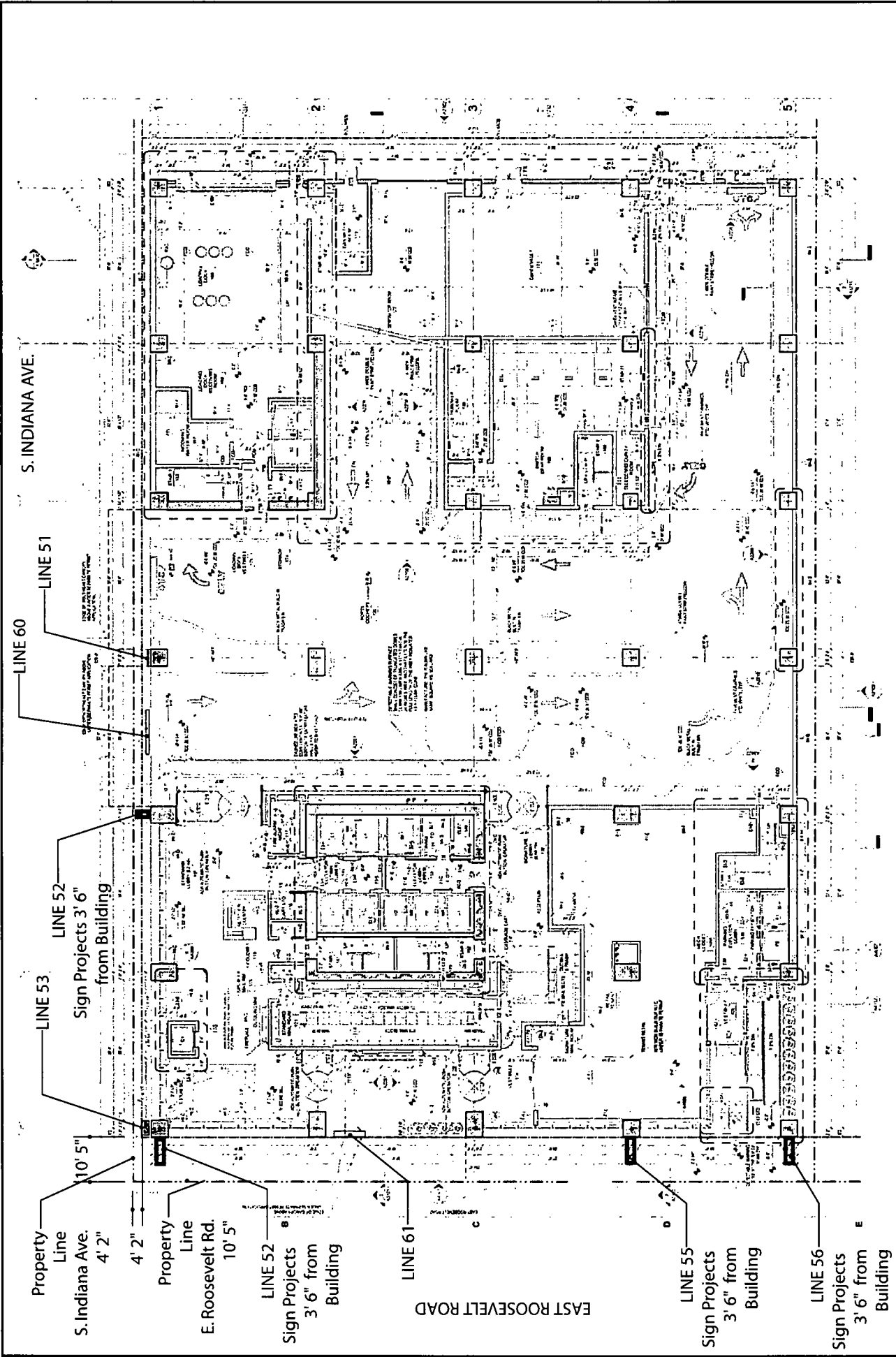
