

ORDINANCE

to those of a C1-1 Neighborhood Commercial District.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about February 23, 2022, the undersigned will file an application for a change in zoning from B1-1 Neighborhood Shopping District to C1-1 Neighborhood Commercial District, on behalf of BRINSWOP II LLC, an Illinois limited liability company, for the property located at 2504 W. 63rd Street, Chicago, Illinois and described as follows:

The public alley next north of and parallel to West 63rd Street, South Campbell Avenue, West 63rd Street, a line 58.20 feet west of the west line of South Campbell Avenue.

The property is currently improved with 9 dwelling units and commercial space on the first floor. The purpose of the zoning amendment is to permit a portion of the first floor to be occupied with a use permitted in the C1 district.
