## SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Chicago Department of Transportation, the Commissioner or any of her designees, are hereby authorized and directed to approve a proposed Sauganash Glen Subdivision being a subdivision bounded by N. Kostner Avenue, W. Peterson Avenue, N. Keeler Avenue and N. Sauganash Avenue, as legally described in the attached plat (Exhibit A, CDOT File:03-39-14-3646) which, for greater certainty, is hereby made a part of this ordinance. Further, the Commissioner is authorized to approve the acceptance of the dedications shown on such drawing.

SECTION 2. The dedications for a public street and adjacent alleys are accepted upon the express condition that they be constructed according to the most current version of the Chicago Department of Transportation *Regulations for Opening, Repair and Construction in the Public Way* and its appendices, and as agreed to by the applicant in the attached Duty to Build Agreement (Exhibit B), hereby made a part of this ordinance.

SECTION 3. The subdivision and dedications herein provided for are made upon the express condition that within 180 days after the passage of this ordinance, K. Hovnanian at Sauganash Glen, LLC shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of removing paving and curb returns; and constructing sidewalk, curb, street and alley in the areas to be dedicated.

SECTION 4. The City of Chicago hereby reserves for the benefit of Comcast, AT&T/SBC and their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the areas herein subdivided, with the right of ingress and egress. The grade of the areas to be subdivided shall not be altered in a manner so as to interfere with the operation and maintenance of Comcast and AT&T/SBC facilities. No buildings, permanent structures or obstructions shall be placed over Comcast and AT&T/SBC facilities without written release of easements by the respective utilities. Any future utility relocations lying within the area being subdivided will be accomplished by the involved utility and be done at the expense of beneficiary of the subdivision.

SECTION 5. The subdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the applicant shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the attached Plat approved by the Department of Transportation / Superintendent of Maps

SECTION 6. This ordinance and exhibit subdivision plat shall take effect and be in force from and after its recording.


