SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 18-J in the area bounded by

West 71<sup>st</sup> Street; a line 142.95 feet east of and parallel to South Sawyer Avenue; the public alley next south of and parallel to West 71<sup>st</sup> Street; a line 42.95 feet east of and parallel to South Sawyer Avenue,

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

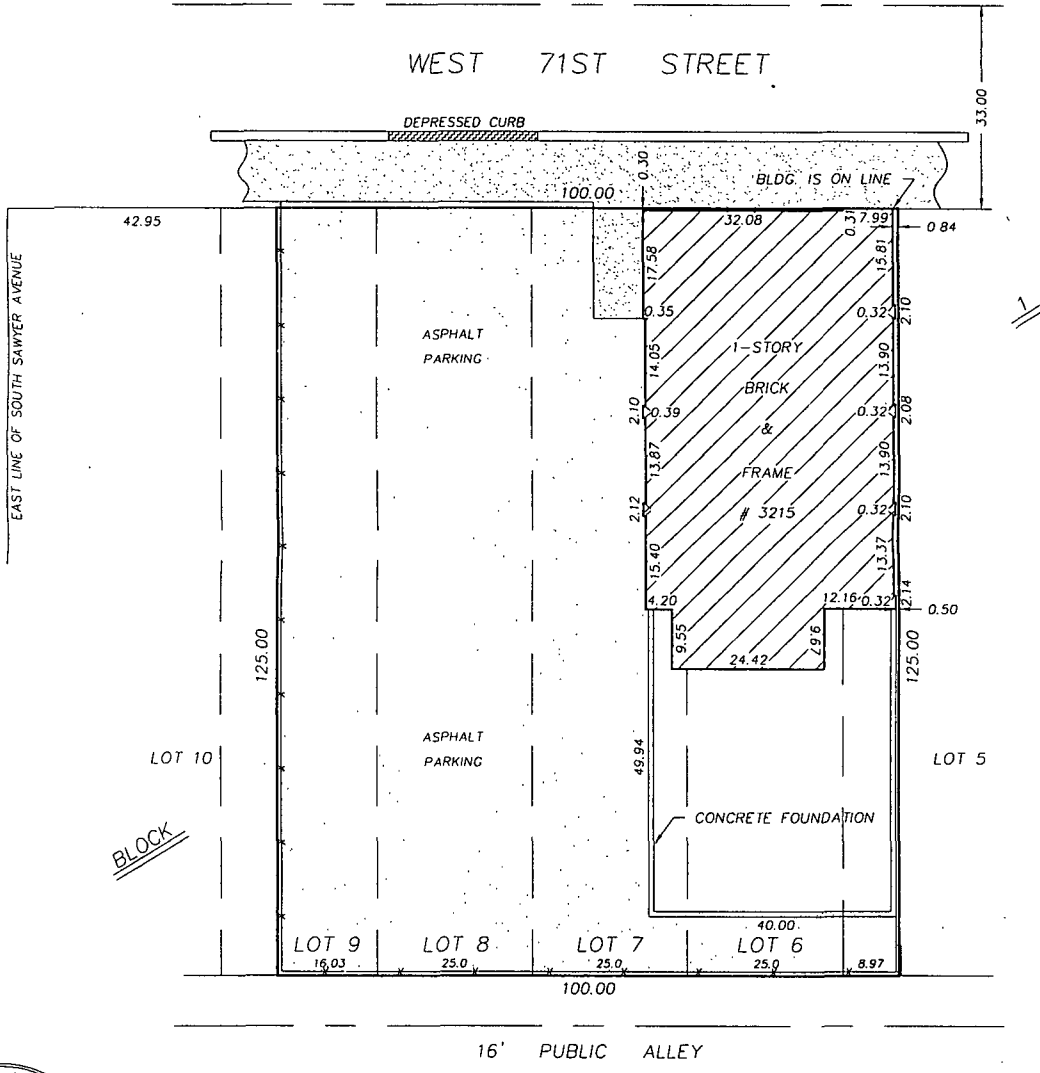
