to those of a B3-5 Community Shopping District which is hereby established in the area described above.

SECTION 2. That the Chicago Zoning Ordinance be amended by changing all the current B3-5 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by:

West Division Street; North Ashland Avenue; a line 122.25 feet south of West Division Street; and a line 149.02 feet west of North Ashland Avenue

to those of Residential-Business Planned Development which is hereby established in the area described above and subject to such use and bulk regulations as are set forth in the Planned Development attached hereto and to no others.

1. The area delineated herein as a Residential-Business Planned Development Number _____ (the "Planned Development") consists of approximately sixteen thousand, six hundred seventy-eight (16,678) square feet (0.38 acres) of property which is depicted on the attached Planned Development Boundary and Property Line (the "Property") and is owned or controlled for purposes of filing and approval of this Planned Development by 1601 West Division LLC, an Illinois limited liability company (the "Applicant").
2. The Applicant shall obtain all necessary official reviews, approvals or permits. Any dedication or vacation of streets, alleys or easements or any adjustment of right-of-way shall require a separate submittal on behalf of the Applicant and approval by the City Council.
3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal titleholders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal titleholders and ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time applications for amendments, modifications or changes (administrative, legislative or otherwise) (hereafter "Modifications") to this Planned Development are made, shall be under single ownership or under single designated control. Single designated control for purposes of this paragraph shall mean that any application to the City for any Modifications to this Planned Development is made or authorized by the Applicant, its successors and assigns or any property owner's association which is formed.
4. This plan of development consists of fourteen (14) statements; a Bulk Regulations and Data Table; an Existing Zoning Map; a Planned Development Boundary and Property Line all dated October 5, 2011; and a Site Plan (the "Site Plan"), a Green Roof Plan and four (4) drawings depicting the building's elevations (the "Elevations") all prepared by Wheeler Kearns Architects and dated October 5, 2011. Full size copies of these exhibits are on file with the Department of Housing and Economic Development. These and no other zoning controls shall apply to the Property. Temporary signs also shall be permitted within the Planned Development subject to the review and approval of the Department of Housing and Economic Development.
7. Off-street parking shall be provided in compliance with this Planned Development subject to the review and approval of the Department of Transportation. The parking spaces depicted on the Site Plan may be shared between the uses within this Planned Development and the existing use immediately to the west.
8. Any service drive or other ingress or egress shall be adequately designed and paved in accordance with the regulations of the Department of Transportation in effect at the time of construction and in compliance with the Municipal Code of the City of Chicago, to provide ingress and egress for motor vehicles, including emergency vehicles. There shall be no parking within such paved areas. Ingress and egress shall be subject to the review and approval of the Department of Transportation.
9. In addition to the maximum heights of the buildings and any appurtenance attached thereto prescribed in this Planned Development, the height of any improvements shall also be subject to height limitations as approved by the Federal Aviation Administration.

The improvements depicted on the Site Plan and the Elevations, including the landscaping along adjacent rights-of-way and all entrances and exits to and from the parking and loading areas shall be designed, constructed and maintained in substantial conformance with the Site Plan and Elevations, and to the extent not consistent with the landscaping regulations of the Zoning Ordinance, the provisions of this Planned Development shall control.

In furtherance of these goals, the Applicant shall provide green roof areas on buildings in each subarea equal to fifty percent (50%) of the net roof area. "Net roof area" is defined as total roof area minus any required perimeter setbacks, rooftop structures and roof-mounted equipment.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the property shall be reviewed and approved by the Mayor's Office of People with Disabilities ("M O P D.") to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. 




