ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District and RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 15-H in the area bounded by

a line 280.33 feet north of and parallel to West Rosehill Drive as measured along the west right-of-way line of North Clark Street (Ashland); North Clark (Ashland); a line 150 feet north of and parallel to West Rosehill drive as measured along the west right-of-way line of North Clark Street (Ashland); and the alley west of North Clark Street (Ashland),

to those of a B3-2 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

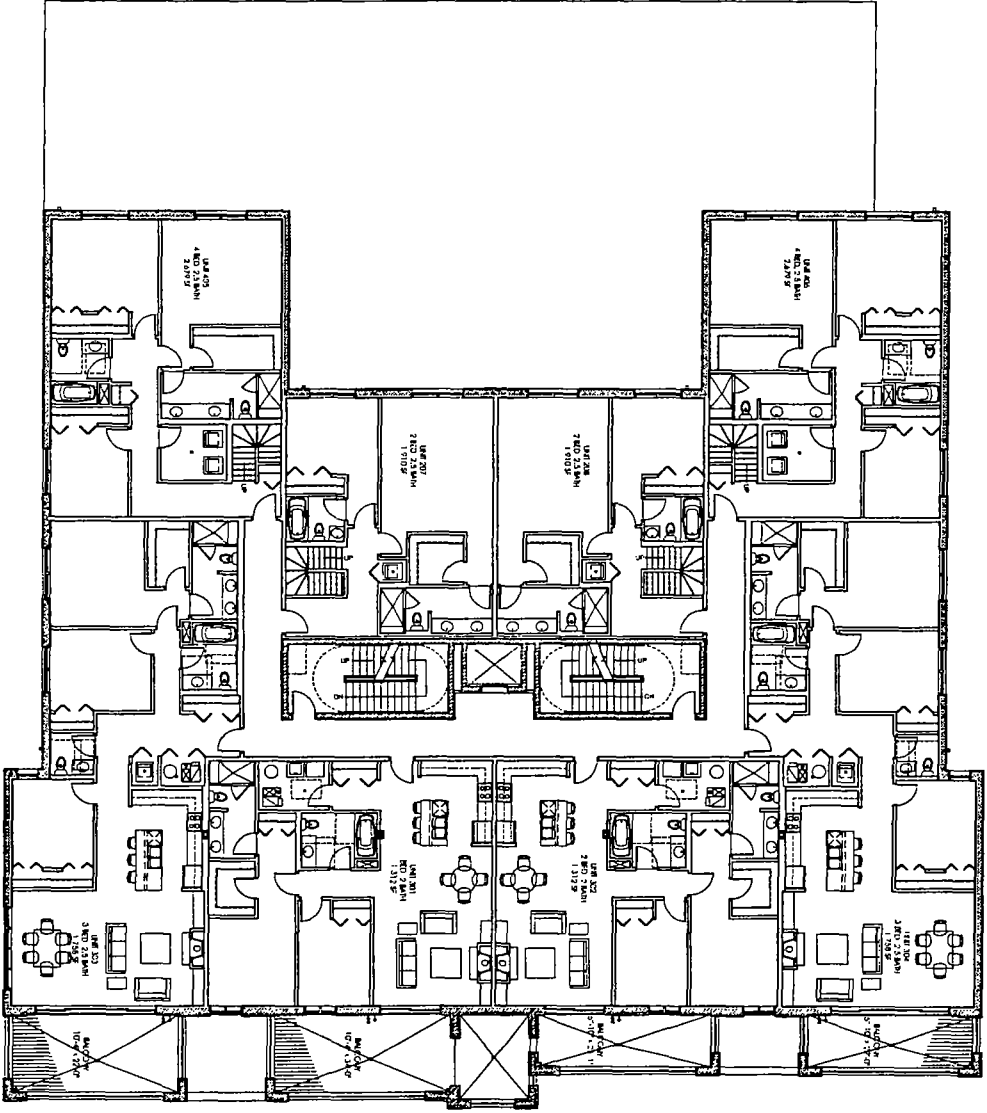
SECOND FLOOR PLAN

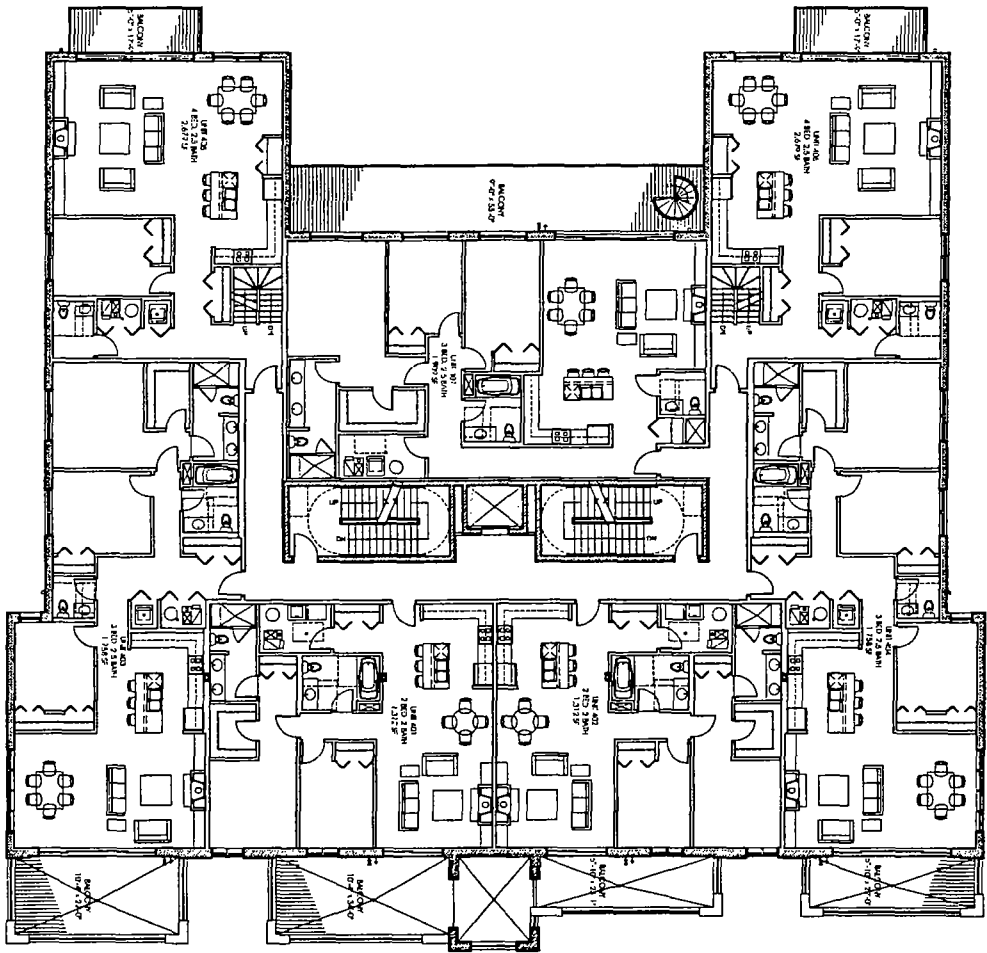


THIRD FLOOR PLAN

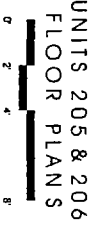


UNITS X03 & X04

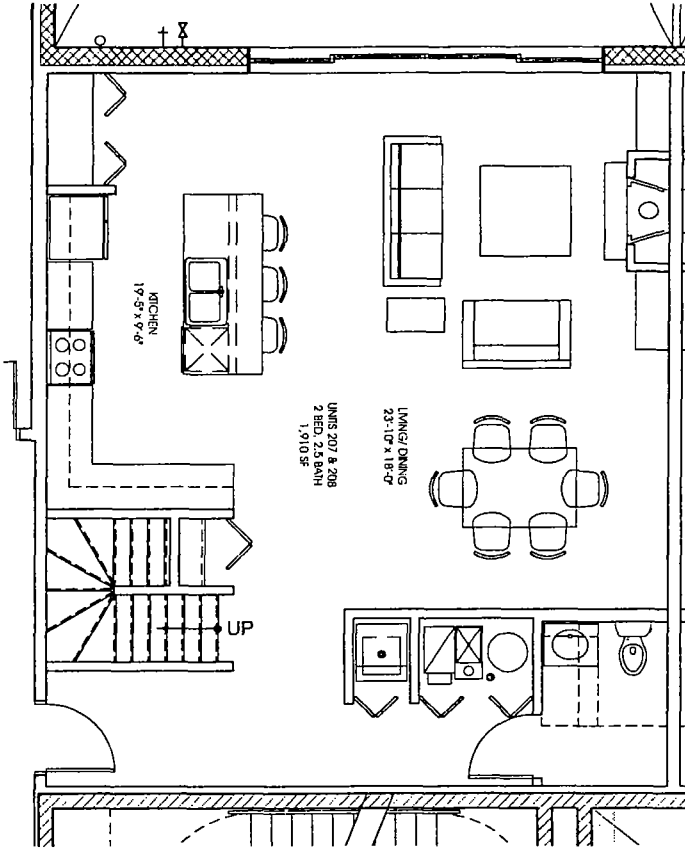

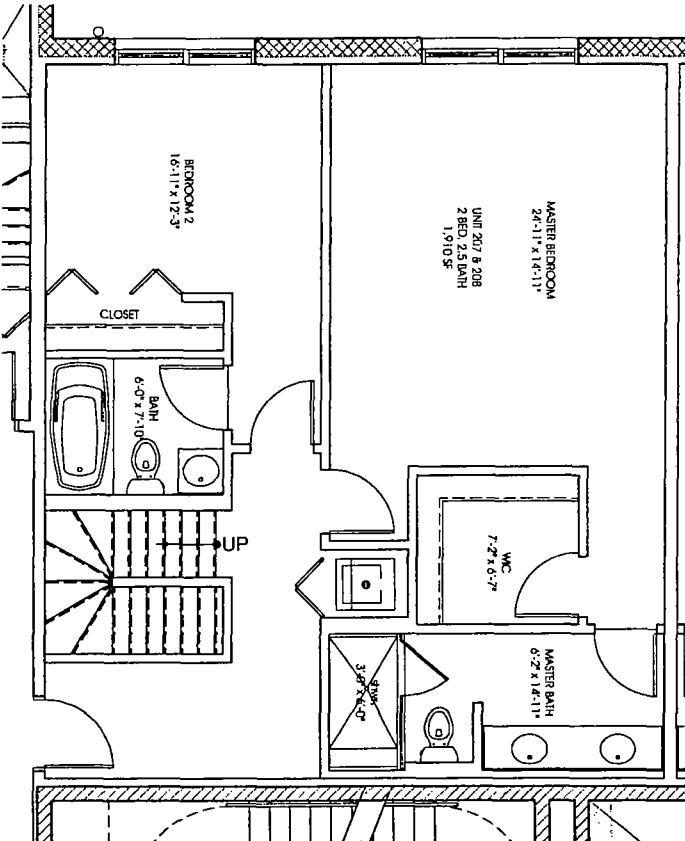

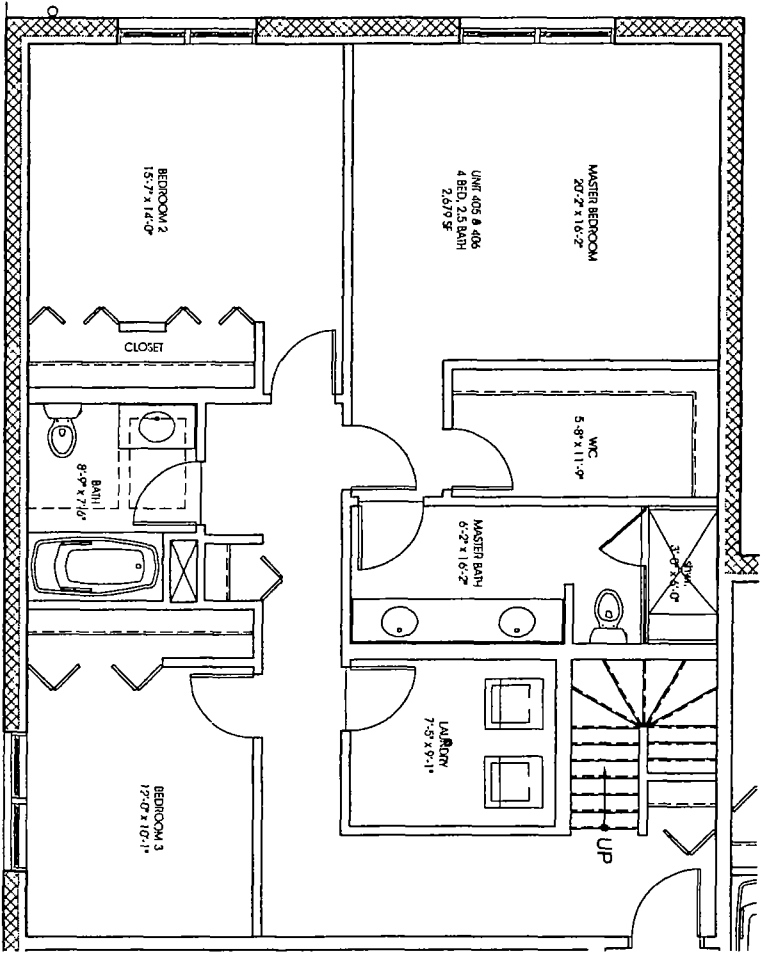


LOWER LEVEL (2ND FLOOR)

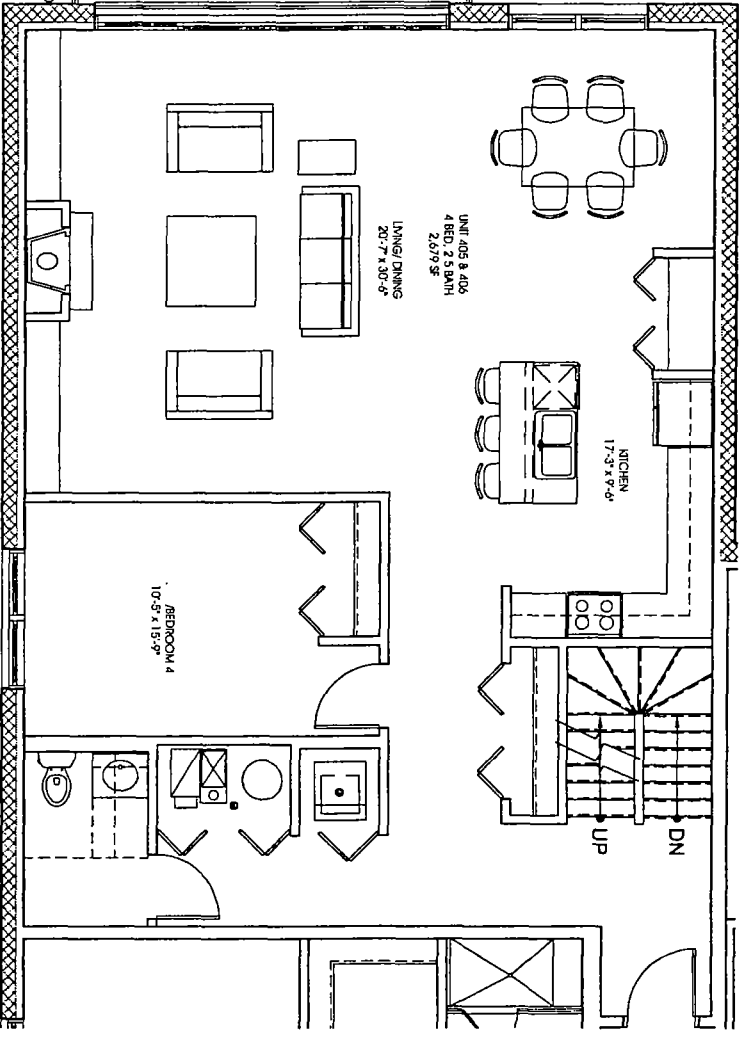


UPPER LEVEL (3RD FLOOR)
