ORDINANCE AMENDMENT Acct. No. 326047 - 3 Permit No. 1099735

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for CITY PROVISIONS CATERING AND EVENTS on 04/18/2012, and printed upon the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words

"Said sidewalk cafe area #1 shall be fifty-three point five (53.5) feet in length and eleven (11) feet in width for a total of five hundred eighty-eight point five (588.5) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along Wilson Ave. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Tuesday through Thursday 8:00 a.m. until 9:00 p.m. Friday and Saturday 8:00 a.m. until 10:00 p.m. Sunday 9:00 a.m. until 7:00 p.m. Compensation: \$600.00 SEATING CAPACITY: 30"

and inserting in their place the words

"Said sidewalk cafe area #1 shall be fifty-six point five (56.5) feet in length and thirteen point eight (13.8) feet in width for a total of seven hundred seventy-nine point seven (779.7) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along Wilson Ave. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Tuesday through Thursday 9:00 a.m. until 9:00 p.m. Friday and Saturday 9:00 a.m. until 10:00 p.m. Sunday 9:00 a.m. until 4:00 p.m. Compensation: \$857.67 SEATING CAPACITY: 40"

Section 2:

This ordinance Amendment shall be in effect upon its passage.
