## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 11-H in the area bounded by

the alley next north of and parallel to West Irving Park Road; a line 175.00 feet east of and parallel to North Hoyne Avenue; West Irving Park Road; and a line 112.50 feet east of and parallel to North Hoyne Avenue,

to those of a B2-3 Neighborhood Mixed-Use District.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

Proposed Land Use: The subject property consists of two contiguous lots of record. The west parcel (*Lot 52*) is presently improved with a vacant two-and-half-story multi-unit *residential* building, while the east parcel (*Lot 53*) is presently vacant and unimproved. The existing improvements are *non-conforming* under the current Zoning Ordinance (*B1-1*). The Applicant is seeking a *Zoning Map Amendment* in order to raze the existing *non-conforming* structures and to redevelop the site, in its entirety, with a new four-story multi-unit *residential* building. 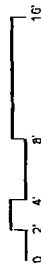
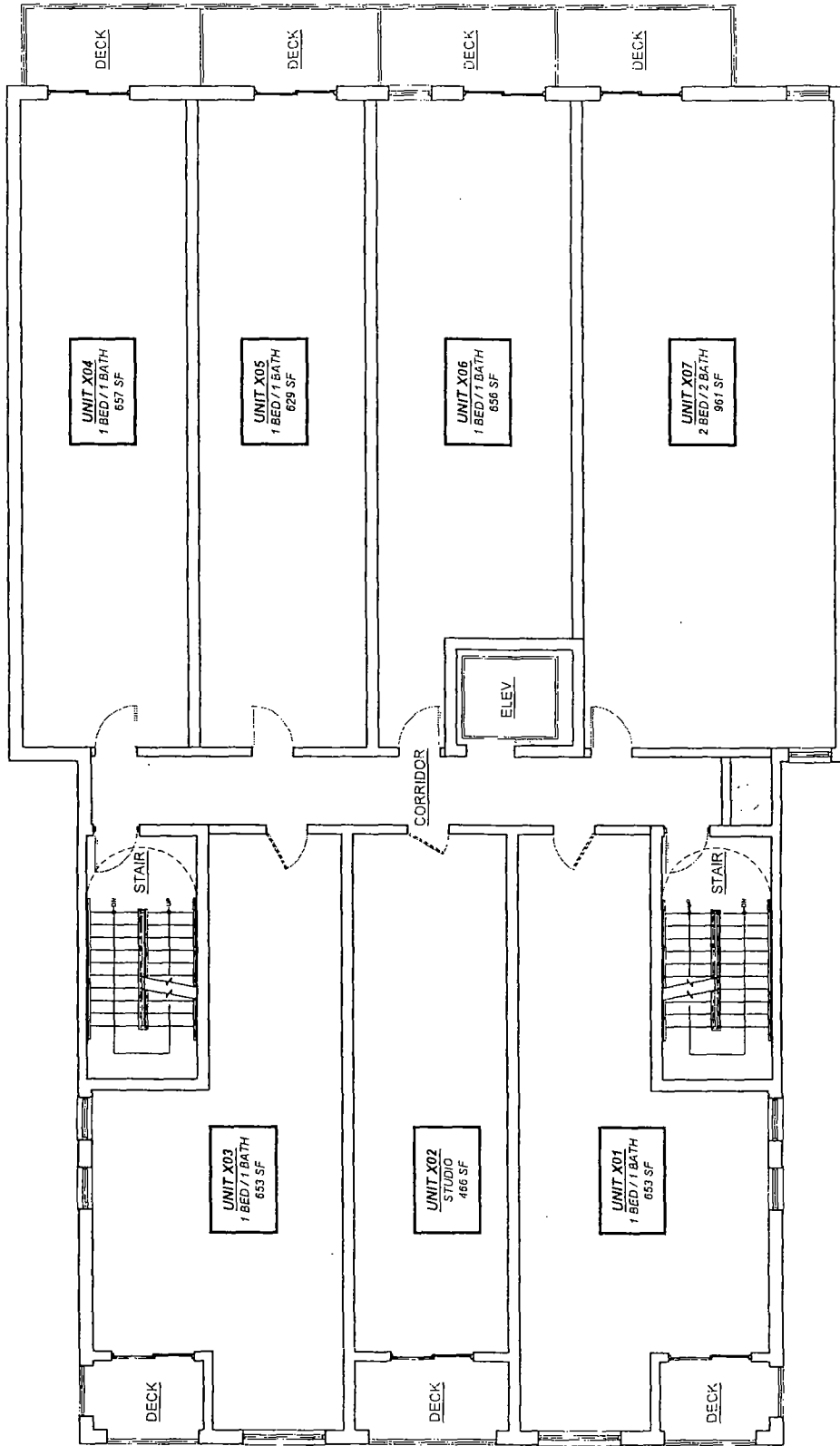


**1 1ST FLOOR PLAN**
