PRINCIPAL OF HANNAH G. SOLOMON SCHOOL*

WHEREAS, Susan Moy is retiring as Principal of Hannah G. Solomon School after more thirty years with the Chicago Board of Education; and

WHEREAS, The Chicago City Council has been informed of this occasion by The Honorable Margaret Laurino, Alderman of the 39th Ward; and

WHEREAS, Susan Moy received a B.A. in Elementary Education from Northeastern Illinois University in 1974; and

WHEREAS, Susan Moy received a M.A. in Asian History from the University of Wisconsin, Madison in 1978; and

WHEREAS, Susan Moy received a M.A. in General Administration from Northeastern Illinois University; and

WHEREAS, Susan Moy began her career with the Chicago Board of Education as a teacher at John C. Haynes School in Chicago from 1974 until 1975; and

WHEREAS, Susan Moy taught at Helge A. Haugan School from 1976 until 1977; and

WHEREAS, Susan Moy was the Asian Resource teacher at Oak Park School District #97, providing resources and workshops for administrators and teachers, from 1977 until 1978; and

WHEREAS, Susan Moy was a teacher at James Ward School from 1983 until 1999, where she taught grades 3, 4 and 7; and

WHEREAS, Susan Moy was Team Leader, Local School Council Teacher Representative, History Fair Coordinator and After School Director at James Ward School; and

WHEREAS, Susan Moy was Director of Student Services, Bi-Lingual and Testing Coordinator, and Case Manager at Daniel Boone School from 1999 until 2000; and

WHEREAS, Susan Moy was Assistant Principal at Hannah G. Solomon School from 2000 until 2002; and

WHEREAS, Susan Moy, as Assistant Principal at Hannah G. Solomon School, was the Scheduler, managed student discipline, evaluated staff, coordinated Links to Literacy, and was After School Programs Coordinator; and

WHEREAS, Susan Moy was Principal of Hannah G. Solomon School from 2002 until 2012; and

WHEREAS, Susan Moy provided a positive learning environment that fostered lifelong learning for a diverse population of students; and

WHEREAS, Susan Moy was Principal of Hannah G. Solomon School when the school was named as one of the top twenty-five neighborhood schools by Chicago Magazine in 2010; and

WHEREAS, Susan Moy was Principal of Hannah G. Solomon School when the ISAT reading scores rose from 70% in 2003 to 94% in 2011, and ISAT math scores rose from 73% in 2003 to 95% in 2011; and


WHEREAS, Susan Moy was Principal of Hannah G. Solomon School when the school was named one of the top fifty Chicago Middle Schools in 2011, by the Chicago Sun-Times; and

WHEREAS, The leaders of this great City of Chicago are cognizant of the great debt owed to Susan Moy on over thirty years of service with the Chicago Board of Education; now therefore,

Be It Resolved, That we, the Mayor and members of the City Council of the City of Chicago, gathered here this twenty-fifth day of July, 2012, do hereby express our gratitude and heartiest congratulations to Susan Moy as she retires and we extend to this fine citizen our very best wishes for continuing success and fulfillment; and
