LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

1	North Fairfield Avenue; North Fairfield Avenue (west side) from a point 312 feet north of West Wabansia Avenue to a point 207 feet north thereof; 15 Minute Standing Zone, 7:30am to 3:30pm, School Days, Public Benefit -- (16-04935169) [O2016-4917]
1	North Paulina Street; North Paulina Street (east side) from a point 15 feet north of West Division Street to a point 30 feet thereof; No Parking Loading Zone, 9:00am to 2:00am, All Days [O2016-7247]
10	8805 South Burley Avenue; 15 Minute Standing Zone, 7:00am to 6:00pm, Monday through Saturday [O2016-7164]
10	10232 South Avenue N; No Parking Loading Zone, Monday through Friday [O2016-7163]
10	8712 South Commercial Avenue; No Parking Loading Zone, 7:00am to 6:00pm, Monday through Saturday [O2016-7165]
14	South St. Louis Avenue; South St Louis Avenue (east side) from South Archer Avenue to first alley north thereof; 15 Minute Standing Zone, Use Flashing Lights, 9:00am to 7:00pm, All Days, Public Benefit [O2016-4408]
20	East 61st Street; East 61st Street (south side) from a point 20 feet west of South Cottage Grove Avenue to a point 40 feet west thereof; 15 Minute Standing Zone, Use Flashing Lights, 8:00am to 7:00pm, Monday through Friday -- (15-05918972) [Or2015-596]
27	1048 West Randolph Street; West Randolph Street (north side) from a point 30 feet east of North Aberdeen Street to a point 20 feet east thereof; No Parking Loading Zone, 6:00am to 2:00am, All Days -- (16-00506216) [O2016-850]
42	661 West Walnut Street; West Walnut Street (south side) from a point 55 feet east of North Union Avenue to a point 20 feet east thereof; 15 Minute Loading Zone, Use Flashing Lights, 5:00pm to 12:00am, Tuesday through Saturday -- (16-00939495) [O2016-529]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
