NORTHWESTERN MEMORIAL HOSPITAL

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to NORTHWESTERN MEMORIAL HOSPITAL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Sheeting(s) under the public right-of-way adjacent to its premises known as 259 E. Erie St..

Said Sheeting(s) at 239-259 E. Erie Street measure(s):

One (1) at two hundred one point eight three (201.83) feet in length, and five point three three (5.33) feet in width for a total of one thousand seventy-five point seven five (1075.75) square feet. Existing sheeting is approximately three (3) feet below grade.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127792 herein granted the sum of two thousand nine hundred sixty (\$2,960.00) per annum in advance.

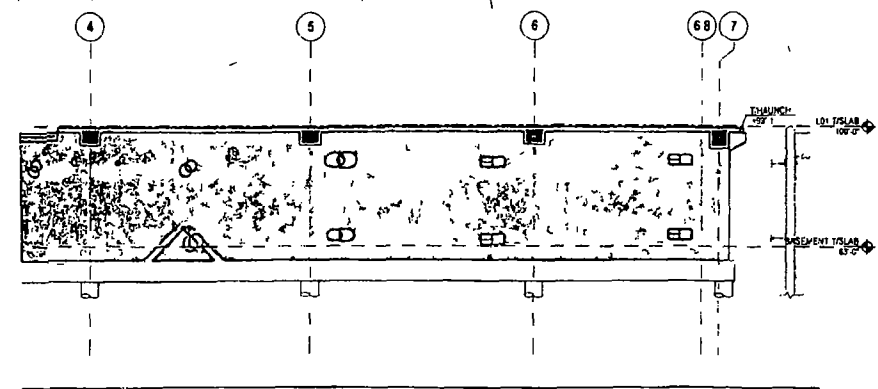
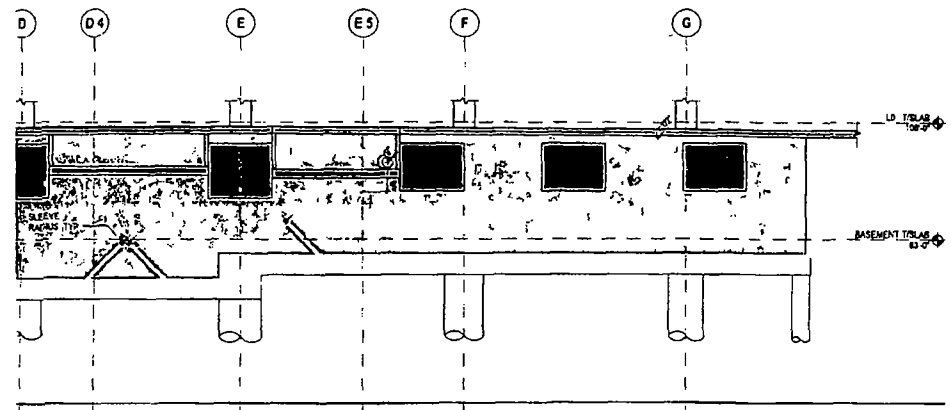
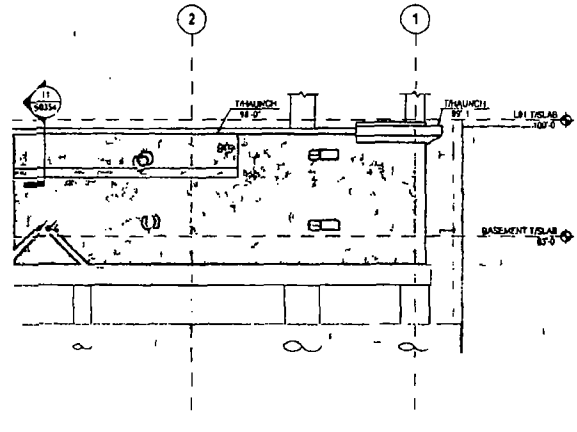
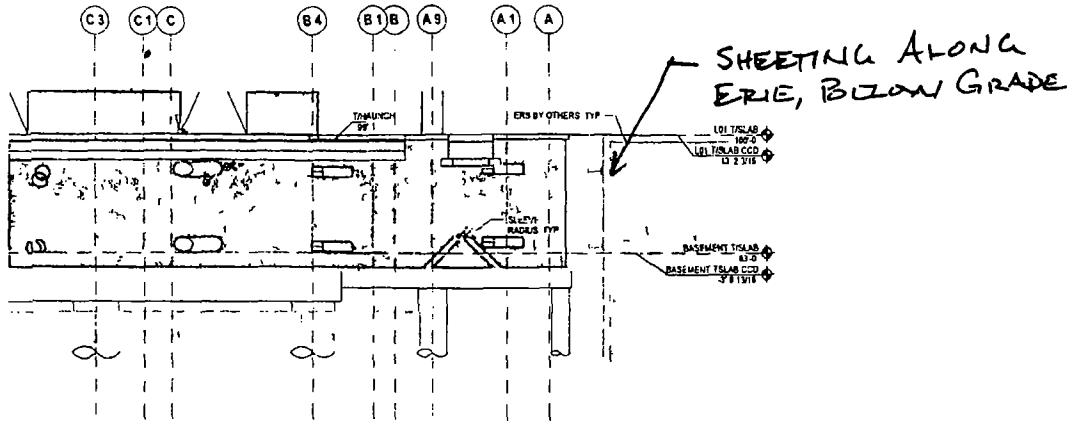
A 25% penalty will be added for payments received after due date.

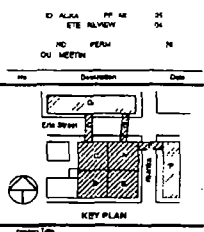
