ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 7-M in the area bounded by:

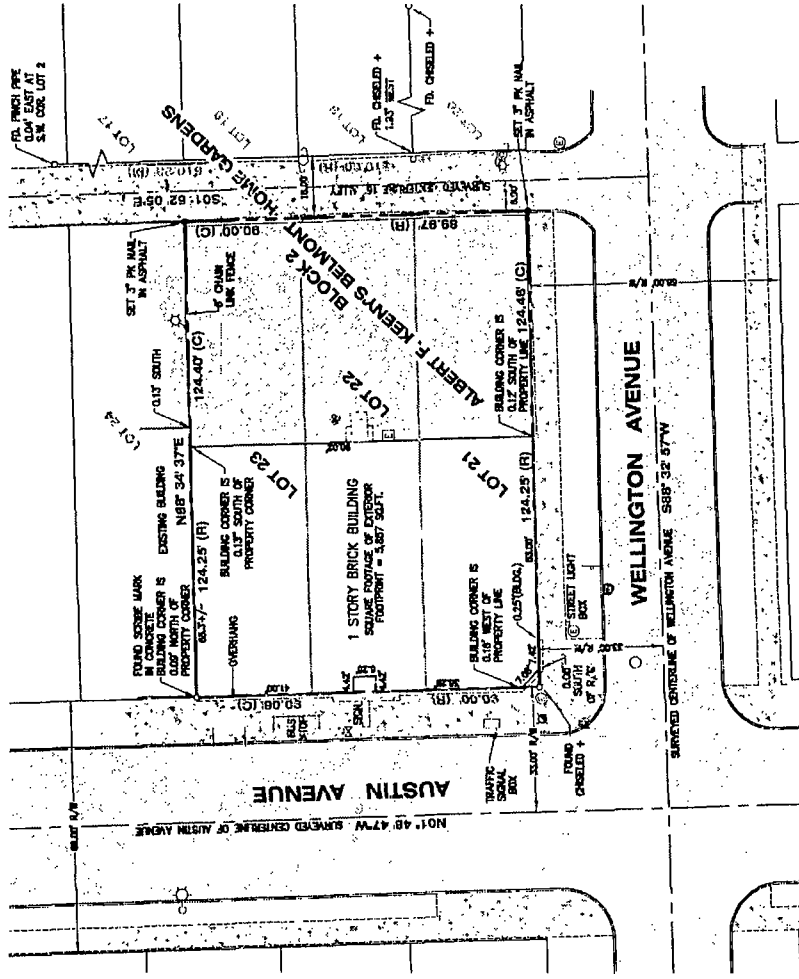
A line 90 feet north of and parallel to West Wellington Avenue; the alley next east of and parallel to North Austin Avenue; West Wellington Avenue and North Austin Avenue.

To those of a C1-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.
