CITY COUNCIL MEETING

THIS ORDINANCE SHOULD BE USED IN RELATION TO CITY FEES FOR A PERIOD OF TWO YEARS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Commissioner of the Department of Construction and Permits, the Director of the Department of Business Affairs and Consumer Protection, the Commissioner of Transportation, the Commissioner of Streets and Sanitation, the Commissioner of the Department of Water Management and the Commissioner of Fire, are hereby directed to issue all necessary permits, all on-site water/sewer inspection fees and all water/sewer plan review fees, free of charge, notwithstanding other ordinances of the City of Chicago to the Contrary to the to the Access at TPAN (Test Positive Awareness Network), a not-for-profit Illinois Corporation, for the erection and maintenance of building (s) and fuel storage facilities at 5537 N. Broadway, Chicago, Illinois 60660.

Said buildings (s) and all appurtenances thereto shall be used exclusively for charitable purposes and shall not be leased or otherwise used with a view to profit, and the work thereon shall be done in accordance with plans submitted and all of the appropriate provisions of the Municipal Code of the City of Chicago and departmental requirements of various departments of the City of Chicago, and said building (s) and all appurtenances thereto shall be constructed and maintained so that they shall comply in all respects with the requirements of the appropriate provisions of the Municipal Code of the City of Chicago for the issuance of all permits and licenses.

SECTION 2. Access at TPAN, a not-for-profit, Illinois Corporation, Located at **5537 N. Broadway**, engaged in **social and health services** and related activities shall be exempt from the payment of City license fees and shall be entitled to the cancellation of warrants for collection for inspection fees.

SECTION 3. Access at TPAN shall be entitled to the refund of City fees which it has paid and to which it is exempt pursuant to Section 1 and 2 of this ordinance.

SECTION 4. This ordinance shall be in force for a period from October 5, 2011 and ending October 5, 2013.

Dear Alderman Osterman:

On behalf of ACCESS at TPAN, this is to request that you introduce into the Chicago City Council during its October 5, 2011 meeting an ordinance to waive all City license, permit and inspection fees for the 2012-2014 licensing periods. Your favorable consideration of this matter is appreciated, as the institution's City of Chicago operating license will expire on January 15, 2012.

Per staff from the City Council Committee on Finance, we have been asked to attach a sample ordinance to this letter for your review.

ACCESS Community Health Network is participating in a program offered by the Metropolitan Chicago Healthcare Council (MCHC). This program, which was initially suggested by various members of the Chicago City Council and their staff, is designed to promote efficiency and expediency between Chicago's hospitals and the City of Chicago's licensing process. The program will better coordinate the institutions with City agencies responsible for licensing and enforcement. It also will promote prompt compliance with Chicago's hospital and other business license laws, and preserve the strong relationships that each institution has with its respective alderman.
