BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 5-J in the area bounded by

The perpendicular public alley to North Kedzie Avenue and next north of and parallel to West Armitage Avenue; North Kedzie Avenue; West Armitage Avenue; a line 35 feet west of and parallel to North Kedzie Avenue and perpendicular to West Armitage Avenue,

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.





In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 15, 2015, I, the undersigned, will file an application for a change in zoning from a B3-1 Community Shopping District to a C1-1 Neighborhood Commercial District on behalf of MILOS CHICAGO LLC.


The applicant seeks a zoning amendment to a C1-1 Neighborhood Commercial District in order to allow a tavern which is within 400 feet of another existing tavern.

The applicant intends to use the subject property to allow a tavern in an existing 1-story building of 841 square feet, currently vacant, at 3200 W. Armitage. No changes will be made to the building height. A proposed 605 sq.ft. addition will be constructed for a total of 1446 interior sq.ft. A proposed outdoor patio of 539 sq.ft. will give the tavern a total of 1985 sq.ft. The remaining rear outdoor space of 1887 sq.ft. will also hold a patio leased by the adjacent building at 3204-06 W. Armitage for a different tavern business. Currently there is 1 parking spot at the rear.

The applicant is Milos Chicago LLC, 2357 N. Milwaukee, Chicago, IL 60647. Managers are Daniel Shapiro, Andrew Gould, and Kristofer Nagy. The property owner is EDJ Investments LLC, 1436 E. Thacker St.#408 Des Plaines, Illinois 60016. Edgard Lutfallah and Jihad Jiha are members. The owners of Elsewhere LLC operate the businesses known as Scofflaw, Slippery Slope and SinkSwim in other locations throughout the City.
