ORDINANCE LIFE STORAGE CENTER OF RAVENSWOOD, LLC Acct. No. 326939 - 13 Permit No. 1137078

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to LIFE STORAGE CENTER OF RAVENSWOOD, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use thirteen (13) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 4701 N. Ravenswood Ave..

Said Canopy(s) at W. Leland Avenue measure(s):

Four (4) at fourteen (14) feet in length, and three point zero eight (3.08) feet in width for a total of one hundred seventy-two point four eight (172.48) square feet.

Said Canopy(s) at W. Leland Avenue measure(s):

One (1) at seventy-one (71) feet in length, and three point zero eight (3.08) feet in width for a total of two hundred eighteen point six eight (218.68) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

Three (3) at nineteen (19) feet in length, and three point zero eight (3.08) feet in width for a total of one hundred seventy-five point five six (175.56) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

One (1) at sixty-five point two five (65.25) feet in length, and three point zero eight (3.08) feet in width for a total of two hundred point nine seven (200.97) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

One (1) at ninety-three (93) feet in length, and three point zero eight (3.08) feet in width for a total of two hundred eighty-six point four (286.44) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

One (1) at eighty-seven point two five (87.25) feet in length, and three point zero eight (3.08) feet in width for a total of two hundred sixty-eight point seven three (268.73) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

One (1) at seventeen (17) feet in length, and three (3) feet in width for a total of fifty-one (51) square feet.

Said Canopy(s) at N. Ravenswood measure(s):

One (1) at fourteen point four two (14.42) feet in length, and three (3) feet in width for a total of forty-three point two six (43.26) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1137078 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
