
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Two-flat, Townhouse and Multi-unit District symbols and indications as shown on Map No. 15-G in the area bounded by


the Alley next North of West Bryn Mawr Avenue; a line 397.15 East of and parallel to North Wayne Avenue; West Bryn Mawr Avenue; and a line 370.41 feet East of and parallel to North Wayne Avenue

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about April 27, 2018, the undersigned will file an application for a change in zoning from RT-4 to B1-1 on behalf of the Sivananda Yoga Vedanta Center for the property located at 1246 W. Bryn Mawr Avenue.

The applicant intends to continue using the subject property as a yoga center, meditation hall, temple and residence for the Center Director, the same use to which the property has been put since the applicant acquired it in 1972. The reason for the rezoning is to enable the applicant to obtain a limited business license for incidental retail sales of books, devotional items and yoga accessories in a small gift shop which will be located on the second floor of the property. After the business license is obtained, zoning for the property will revert to RT-4. There are no changes being sought to the building or construction occurring on the premises.

The contact person for Center is Robyn Hennon, whose address is 1246 W. Bryn Mawr Avenue, Chicago, IL 60660. Ms. Hennon's phone number is 773-878-7771. The owner of the subject property is the Sivananda Yoga Vedanta Centre, a Canadian not-for-profit corporation pursuant to the Canadian Income Tax Act, located in Val-Morin in Quebec, Canada.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in June 1992, granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(2).

This classification was based on the assumption that your organization's operations would continue as stated in the application If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA)

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the

The law requires you to make your organization's annual return available for public inspection without charge for three years after the due date of the return. You are also required to make available for public inspection a copy of your organization's exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. You can charge only a reasonable fee for reproduction and actual postage costs for the copied materials. The law does not require you to provide copies of public inspection documents that are widely available, such as by posting them on the Internet (World Wide Web) You may be liable for a penalty of \$20 a day for each day you do not make these documents available for public inspection (up to a maximum of \$10,000 in the case of an annual return).


