ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Section 2 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023 (9.319) through (9.346), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

- (9.319) On Parnell Avenue, from 125th Street to 126th Street.
- (9.320) On Parnell Avenue, from 126th Street to 127th Street; and on 126th Place, from Wallace Street to Eggleston Avenue.
- (9.321) On 128th Place, from Union Avenue to Wallace Street.
- (9.322) On 128th Place, from Wallace Street to Eggleston Avenue thence on Eggleston Avenue to 129th Place; and on 127th Place and on 128th Street, from Parnell Avenue to their ends east of Parnell Avenue.
- (9.323) On 129th Place, from Union Avenue to Wallace Street.
- (9.324) On 129th Place, from Wallace Street to Eggleston Avenue.
- (9.325) On Wallace Street, from 125th Street to 127th Street.
- (9.326) On Wallace Street, from 127th Street to 129th Place.
- (9.327) On Parnell Avenue, from 127th Street to 129th Place; and on Normal Avenue, from 128th Street to 129th Street.
- (9.328) On Eggleston Avenue, from 125th Street to 127th Street.
- (9.329) On Stewart Avenue, from 125th Street to 127th Street.
- (9.330) On Harvard Avenue, from 125th Street to 127th Street.
- (9.331) On Princeton Avenue, from 125th Street to 127th Street.

- (9.332) On Yale Avenue, from 125th Street to 127th Street.
- (9.333) On Wentworth Avenue, from 125th Street to 127th Street.
- (9.334) On the east side only of Yale Avenue, from 119th Street to 122nd Street.
- (9.335) On the east side only of Yale Avenue, from 122nd Street to 125th Street.
- (9.336) On Wentworth Avenue, from 119th Street to 121st Street.
- (9.337) On Wentworth Avenue, from 121st Street to 123rd Street.
- (9.338) On Wentworth Avenue, from 123rd Street to 125th Street.
- (9.339) On LaSalle Street, from 119th Street to 121st Street.
- (9.340) On LaSalle Street, from 121st Street to 123rd Street.
- (9.341) On LaSalle Street, from 123rd Street to its terminus south of 125th Street.
- (9.342) On Perry Avenue, from 119th Street to 121st Street.
- (9.343) On Perry Avenue, from 121st Street to 123rd Street.
- (9.344) On Perry Avenue, from 123rd Street to 125th Street.
- (9.345) On Lafayette Avenue, from 119th Street to 121st Street.
- (9.346) On Lafayette Avenue, from 121st Street to 124th Street.
