ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-L in the area bounded by

The public alley perpendicular to North Lorel Avenue and next south of and parallel to West Fullerton Avenue; North Lorel Avenue; a perpendicular line to North Lorel Avenue 108 feet south of and parallel to the public alley next south of and parallel to West Fullerton Avenue; the public alley perpendicular to the public alley next south of and parallel to West Fullerton Avenue and west of and parallel to North Lorel Avenue,

to those of an RM4.5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
