ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 73.03 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue); the public alley next southwest of and parallel to North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 98.03 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue),

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 15, 2012, I, the undersigned, will file an application for a change in zoning from a B1-2 Neighborhood Shopping District to a C1-2 Neighborhood Commercial District on behalf of the Golin Family Trust, owner of the property located at 1368 North Milwaukee Avenue.

The applicant seeks a zoning amendment to a C1-2 Neighborhood Commercial District in order to allow a tavern to expand the existing tavern at 1366 N. Milwaukee to 1368 N. Milwaukee and which is within 400 feet of another existing tavern.

The applicant intends to use the subject property to allow an existing 1-story building of approximately 3000 square feet, currently vacant, to be an expansion of the existing Tavern and Public Place of Amusement with arcade games at 1366 N. Milwaukee to include 1368 N. Milwaukee. No additional changes will be made to the existing space or the building height. Currently there is no parking.
