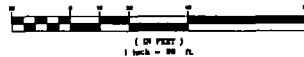

 ILLINOIS.

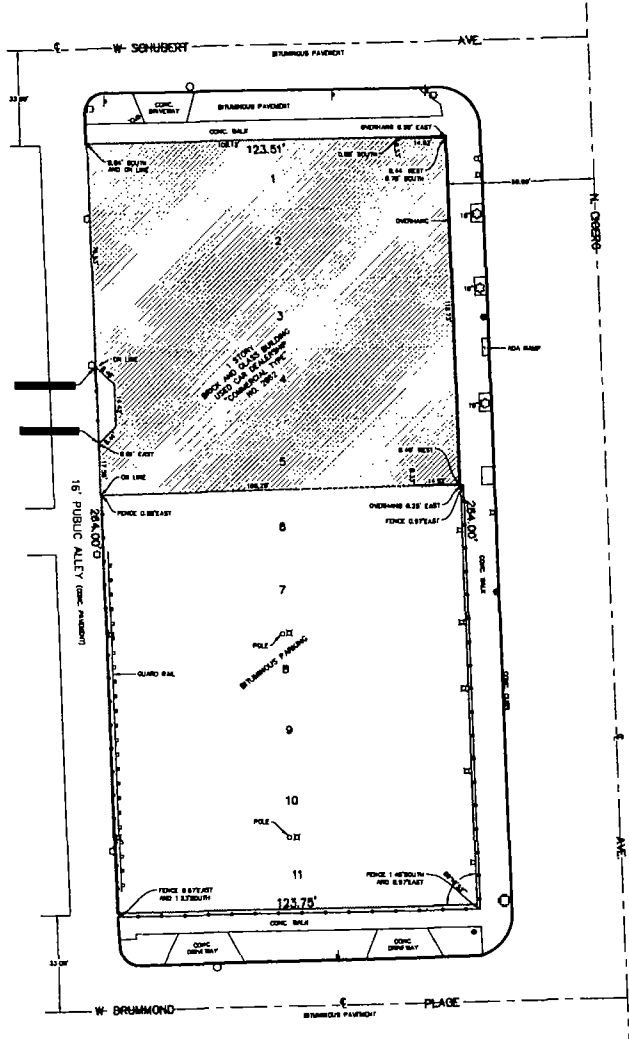
