ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map Number 7-G in the area bounded by:

North Janssen Avenue; a line parallel to and 241.00 feet north of the north line of the right of way of West Fullerton Avenue; the public alley parallel to and west of North Janssen Avenue; and a line parallel to and 266.00 feet north of the north line of the right of way of West Fullerton Avenue

to those of an RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



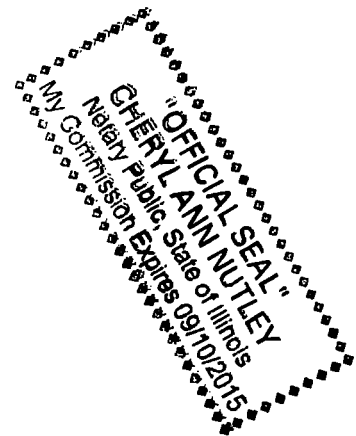

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on January 29, 2015, the undersigned filed an application for a change in zoning from RS-3 Residential Single-Unit (Detached House) District to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District on behalf of the applicant-owner, **Mutaz Abdullah**, for the property located at 2424 N. Janssen Ave.

The applicant-owner intends to build a newly-constructed, three story single family home on the subject property for occupancy by the applicant-owner and his family. The purpose of the zoning change is to permit a building height of 37 feet and a floor area of 3,510 sq.ft. on the subject property, which has dimensions of 25 feet by 117 feet.

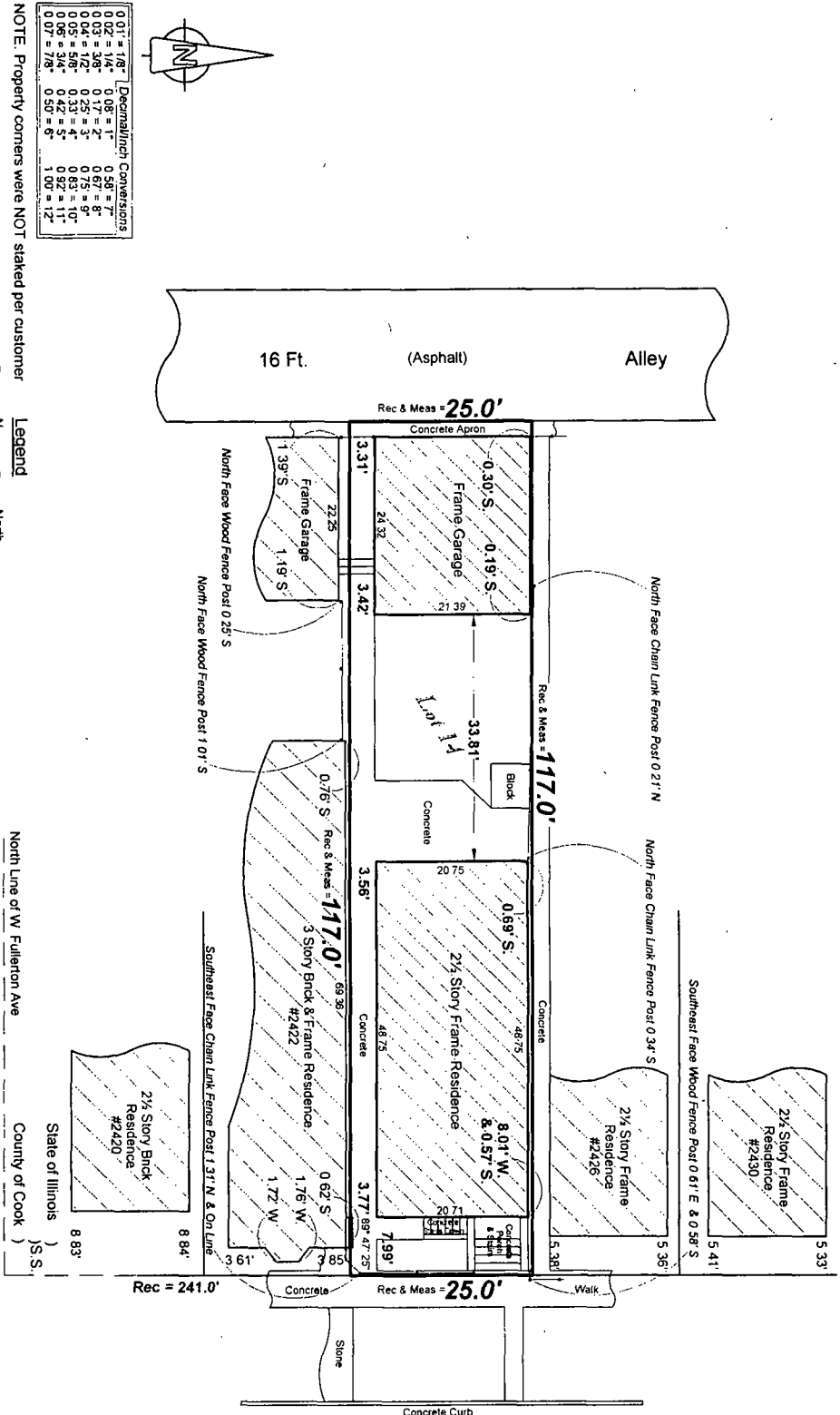

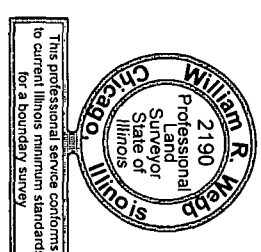

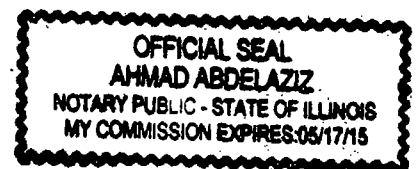
