

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt **Wonder Montessori School** from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for **5634 North Pulaski Road**.

SECTION 2. This ordinance shall take effect and be in force from and after its passage and publication.
