BE IT ORDAINED BY THE CITY OF CHICAGO – CITY COUNCIL:

SECTION 1. Title 17 of the Municipal Code of Chicago - the *Chicago Zoning Ordinance*, be amended by changing all the *B3-2 Community Shopping District* symbols and indications as shown on Map No. 5-H in the area bounded by

the alley next north of and parallel to West Webster Avenue; a line 100 feet east of and parallel North Seeley Avenue; West Webster Avenue; and a line 50 feet east of and parallel to North Seeley Avenue,

to those of a *B2-3 Neighborhood Mixed-Use District*.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
