**ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code, the Chicago Zoning Ordinance,  
be amended by changing all the B1-1 Neighborhood Shopping District symbols and  
indications as shown on Map No.18-K in the area bounded by

a line 88.72' north of and parallel to West 78<sup>th</sup> Street; the public alley next  
east of and parallel to South Cicero Avenue; West 78<sup>th</sup> Street; and South  
Cicero Avenue;

to those of a B3-1 Community Shopping District is hereby established in the  
area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and  
due publication.

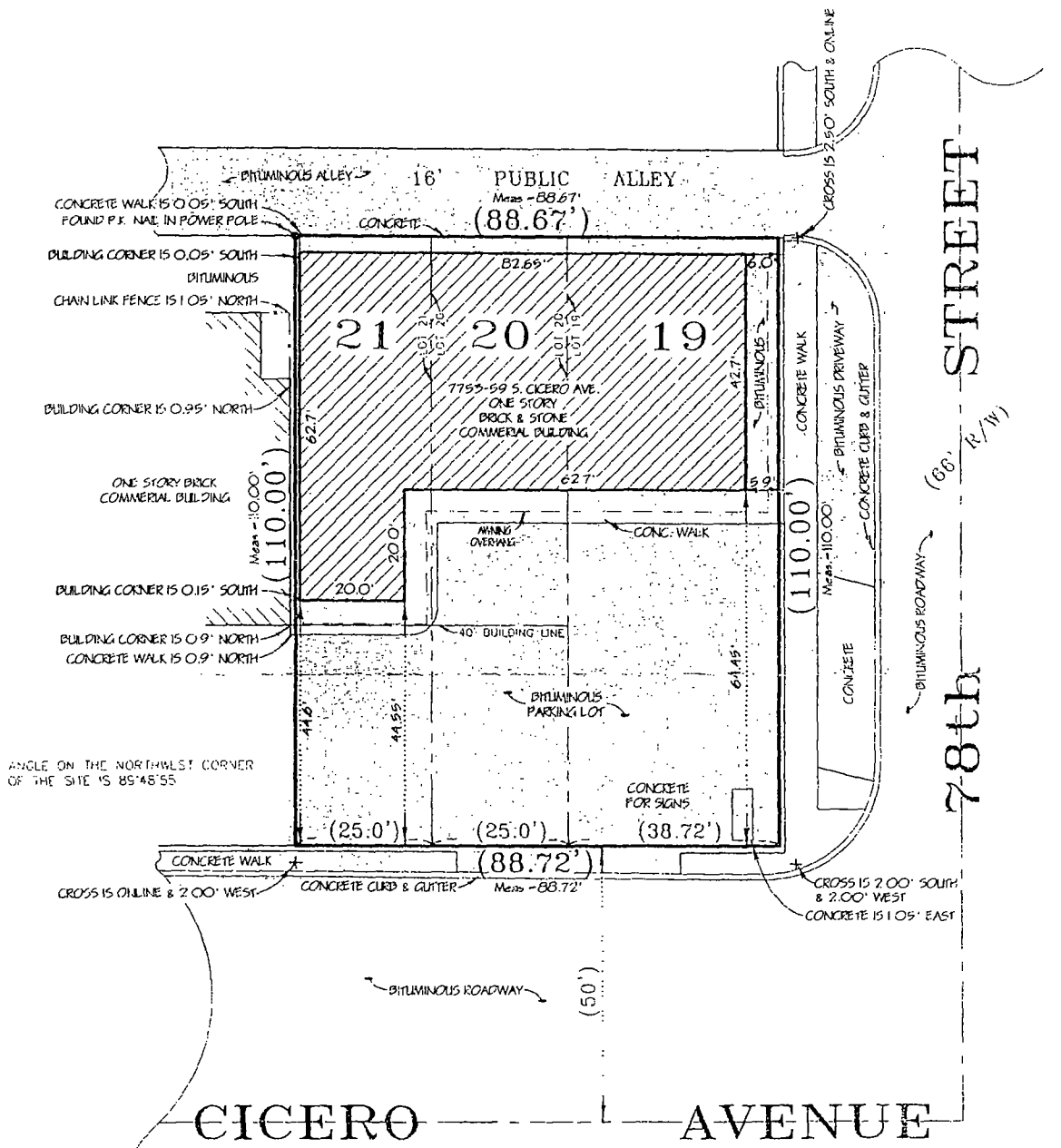
