ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 7-H in the area bounded by:

A line 350.00 feet southeasterly of West Terra Cotta Place as measured along the northeasterly line of North Clybourn Avenue and perpendicular thereto; the public alley next northeast of North Clybourn Avenue; a line 400.00 feet southeasterly of West Terra Cotta Place as measured along the northeasterly line of North Clybourn Avenue and perpendicular thereto; North Clybourn Avenue

to those of a B3-3 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

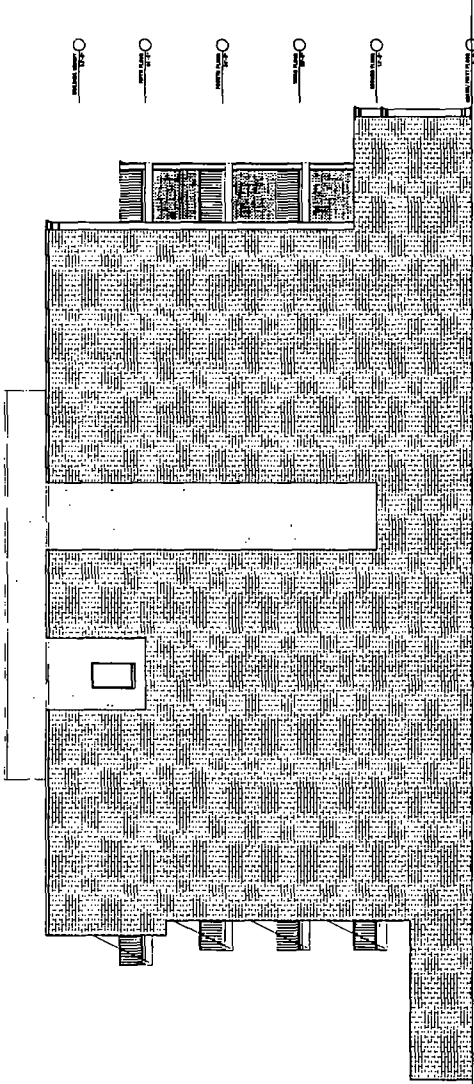

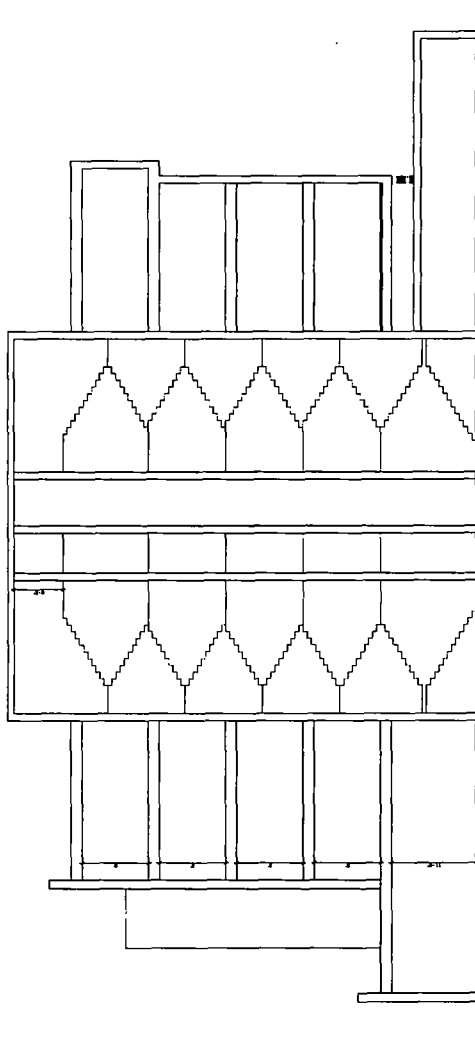
