BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 18-I in the area bounded by:

A line 366 feet south of and parallel to West 77th Street; the public alley next east of and parallel to South Kedzie Avenue; a line 416 feet south of and parallel to West 77th Street; and South Kedzie Avenue.

to those of a C1-1 Neighborhood Commercial.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

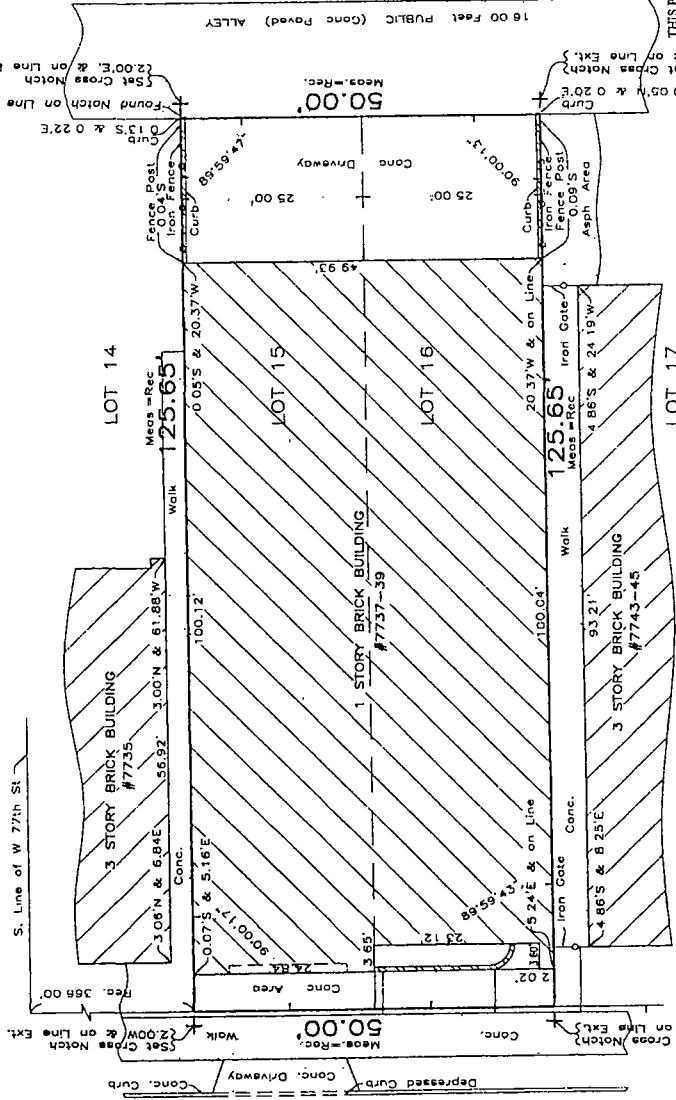
