STARBUCKS COFFEE #2443

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to STARBUCKS COFFEE #2443, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 1588 N. Milwaukee Ave..

Said sign structure(s) measures as follows; along N. Milwaukee Avenue:  
One (1) at two (2) feet in length, two (2) feet in height and fourteen (14) feet above grade level.  
Two (2) at twelve (12) feet in length, one point six seven (1.67) feet in height and fourteen (14) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1145158 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

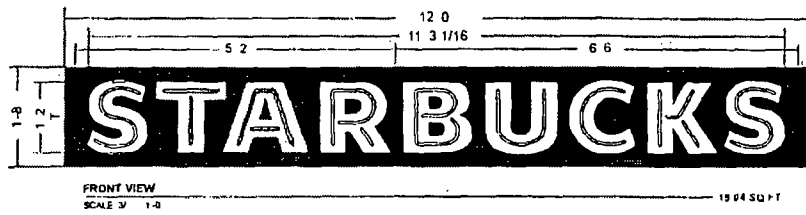

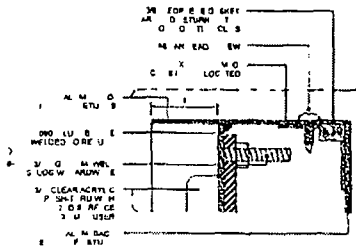

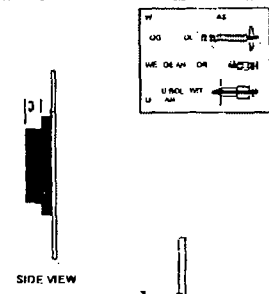
FRONT VIEW

**SPECIFICATIONS**

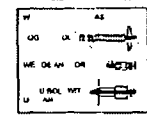
- A Internally illuminated channel letters fabricated from 6063 aluminum with welded returns. Letter returns, backs painted matte black. Internal baffles to be painted white.
- B Channel letters to have open faces with exposed push thru features and recessed internal baffles.
- C Illumination - 30 Stan Enlighten LEDs with power supplies mounted in a weatherproof UL approved transformer box.
- D Channel letters to be mounted flush on 2" Deep x 20" Tall Background painted RAL 7021 and attached to Window Mullions using appropriate fasteners per construction type.
