ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map Number 19-H in the area bounded by:

North Rogers Avenue; the north-south public alley next east of the intersection of North Rogers Avenue and West Chase Avenue; West Chase Avenue; and a line 50.0 feet west of and parallel to the north-south public alley next east of the intersection of North Rogers Avenue and West Chase Avenue

to those of a B2-5 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about December 14, 2022, the undersigned will file an application for a change in zoning from B1-3 Neighborhood Shopping District to B2-5 Neighborhood Mixed-Use District on behalf of the applicant, The Manderly Group I LLC, Series 7319 N Rogers, for the property located at 7319 N. 


