ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-I in the area bound by

West Bloomingdale Avenue; North Artesian Avenue; a line 48 feet south of and parallel to West Bloomingdale Avenue; and the alley next west of and parallel to North Artesian Avenue

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

12. Reason for rezoning the property: The Applicant is seeking a zoning amendment in order to apply for building permits to construct a new three (3) story, six (6) dwelling unit residential building with six (6) parking spaces at the rear of the property.
13. Describe the proposed use of the property after the rezoning. Indicate the number of dwelling units; number of parking spaces; approximate square footage of any commercial space; and height of the proposed building. (BE SPECIFIC)
The Applicant is seeking a zoning amendment in order to construct a new six (6) unit residential building. The building will contain two (2) duplex units that will span the basement and first floors. The second and third floors will each contain two (2) dwelling units, for a total of four (4) simplex units. The proposed building will contain no commercial space. The applicant will provide six (6) on-site parking spaces at the rear of the lot. 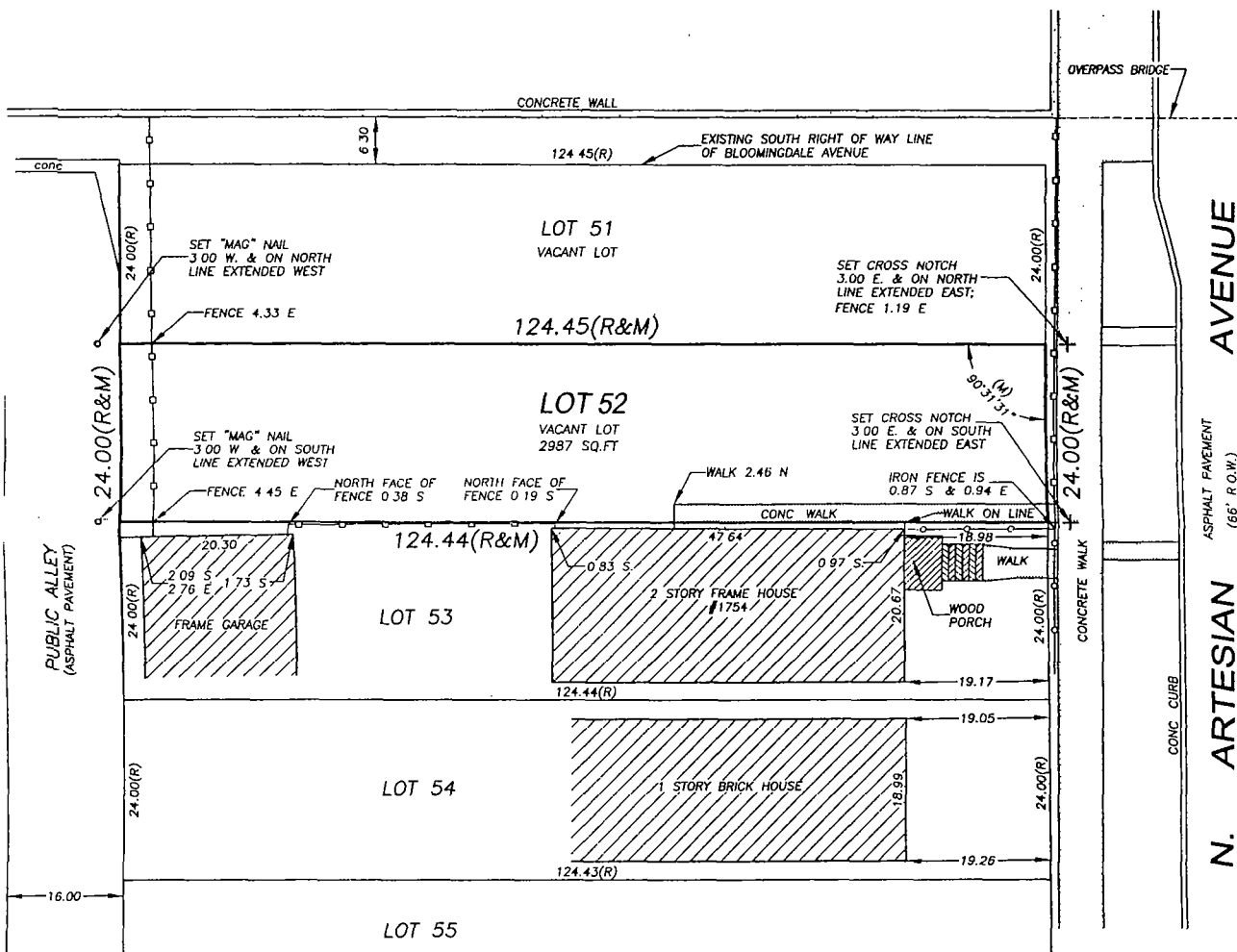
