## TRIBUTE TO OTTO J. JAEGER

WHEREAS, In His Infinite Wisdom, Almighty God has granted eternal rest to Otto J. Jeager, a member of the Greatest Generation and outstanding member of the business community; and

WHEREAS, Otto J. Jaeger lived a majority of his four score and four years in the service of his fellow citizens.
