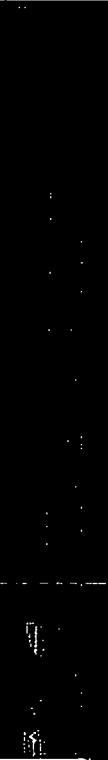
# CITI TRENDS
