ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-5 Neighborhood Shopping District and B3-3 Community Shopping District symbols and indications as shown on Map No.12-E in the area bounded by

a line 83 feet south of and parallel to East 47th Street; South Dr. Martin Luther King Jr. Drive; a line 150 feet south of and parallel to East 47th Street; and the alley next west of and parallel to South Dr. Martin Luther King Jr. Drive,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

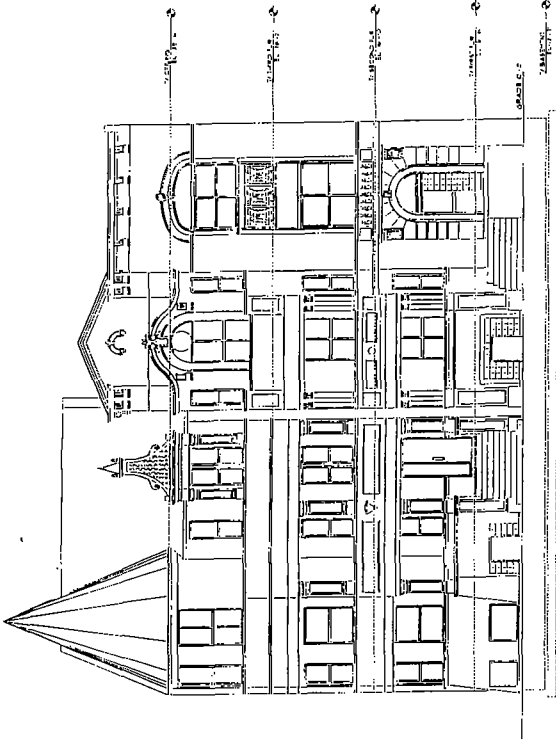
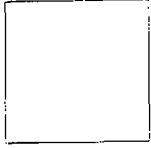
PROPOSED FIRST FLOOR PLAN

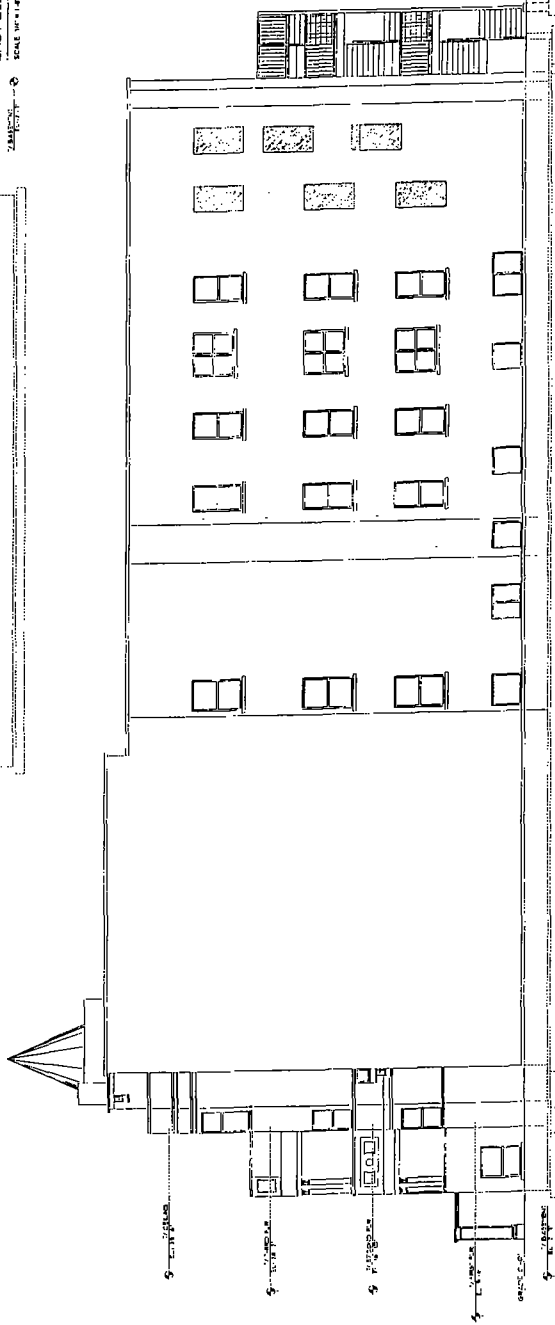
TYP FLOOR PLAN
