#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-5 Neighborhood Shopping District and B3-3 Community Shopping District symbols and indications as shown on Map No.12-E in the area bounded by

a line 83 feet south of and parallel to East 47<sup>th</sup> Street; South Dr. Martin Luther King Jr. Drive; a line 150 feet south of and parallel to East 47<sup>th</sup> Street; and the alley next west of and parallel to South Dr. Martin Luther King Jr. Drive,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.







PROPOSED FIRST FLOOR PLAN
