The alley next north of and parallel to west Barry Avenue; a line 317.85 feet west of and parallel to North Cicero Avenue; west Barry Avenue; and a line 347.85 feet west of and parallel to North Cicero Avenue.

To those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District
