BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for Mama Milano on 5/09/2012 and printed on Page 27172 of the Journal of Proceedings of the City of Chicago is hereby amended by deleting the words "Said sidewalk café area #1 shall be thirteen (13) feet in length and ten (10) feet in width for a total of one hundred thirty (130) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along North Wells. The compensation for said space and the days and hours of operation for the sidewalk café shall be as follows:

Sunday through Saturday 11:00 a.m. until 10:00 p.m.

Compensation: \$600.00 Seating Capacity: 20"

and inserting in their place the words

"Said sidewalk café area #1 shall be eighteen (18) feet in length and ten (10) feet in width for a total of one hundred eighty (180) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along North Wells. The compensation for said space and the days and hours of operation for the sidewalk café shall be as follows:

Sunday through Saturday 11:00 a.m. until 10:00 p.m.

Compensation: \$600.00 Seating Capacity: 24"
