MEMORIAL RESOLUTION

WHEREAS, Evelyn Violet Vera Roebuck, a most beloved citizen, friend and remarkable member of her community in Chicago's great thirty-fourth ward, has been called home by our Lord God and Savior Jesus Christ; and

WHEREAS, In His infinite wisdom our Lord chose, Friday August 17, 2012 to bring His precious daughter, Evelyn Violet Vera Roebuck to her heavenly reward; and

WHEREAS, The Chicago City Council has been informed of her transition by the Honorable Carrie M. Austin, Alderman of the 34th Ward; and

WHEREAS, Evelyn was born February 22, 1933 in Memphis, Tennessee, to her loving parents, Jesse and Rosa Lee Bilbo. She was the eldest of Jesse and Rosa Lee's two children who were pampered and nurtured in a loving environment; and

WHEREAS, The Bilbo Family migrated to Chicago in 1939, making it their home. Evelyn attended and graduated from Wendell Phillips High. WHEREAS, Evelyn Violet Vera Roebuck was a loving mother, grandmother, great grandmother, sister, aunt, friend and neighbor who will be deeply missed, but the memory of her character, intelligence and compassion will live on in those who knew and loved her; and

WHEREAS, In honoring the memory of this much-loved woman, who has been called to life eternal, condolence is often expressed to all those whose lives the deceased may have touched; now, therefore,
