ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago (the *Chicago Zoning Ordinance*), be amended by changing all the *B1-3 Neighborhood Shopping District* symbols and indications as shown on Map Grid Index 5-F in the area bounded by

A line 145.50 feet north of and parallel to West North Avenue; a line 227.84 feet east of and parallel to North Wells Street; a line 117.16 feet north of and parallel to West North Avenue; and North Wells Street,

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


