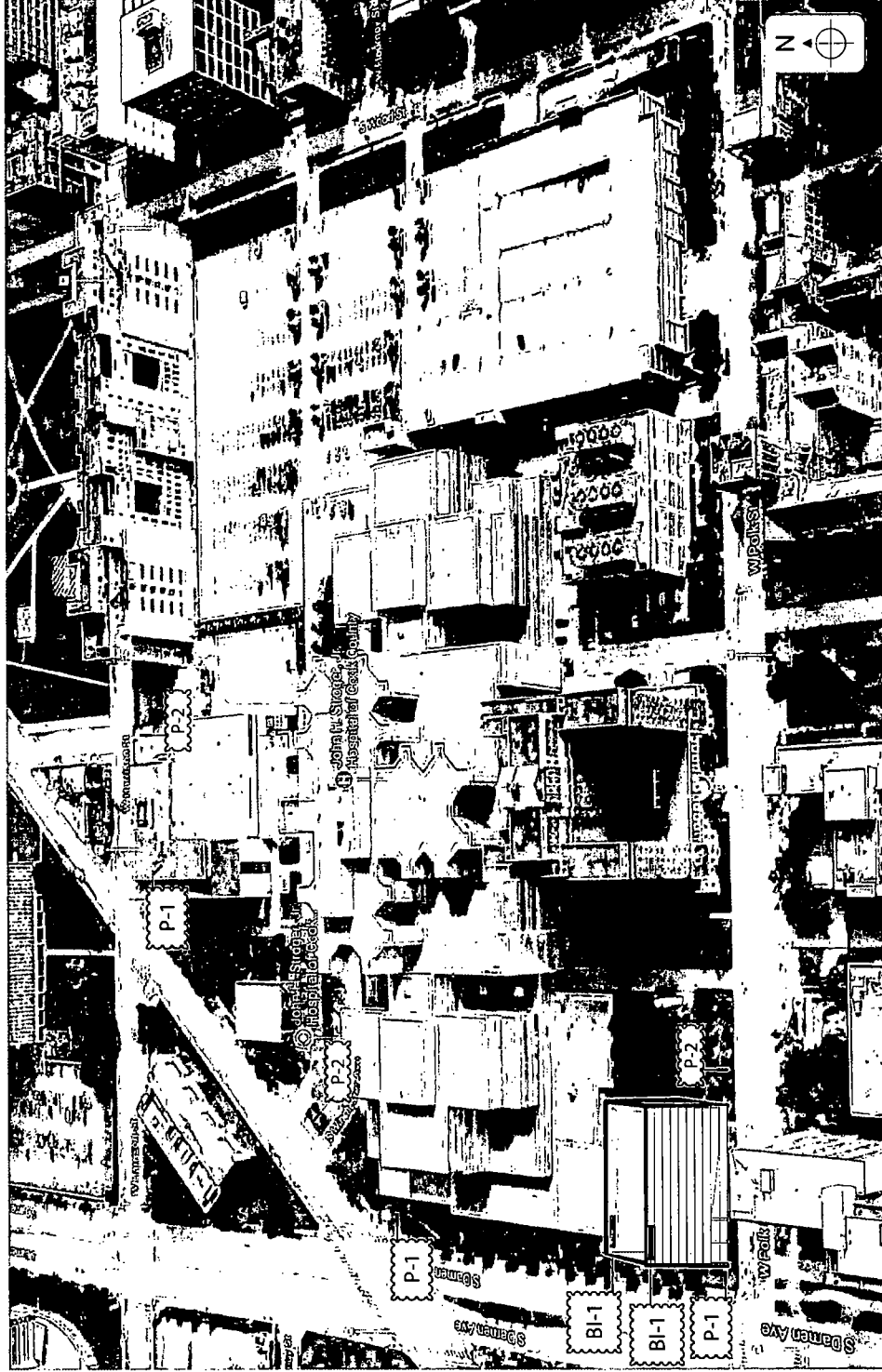

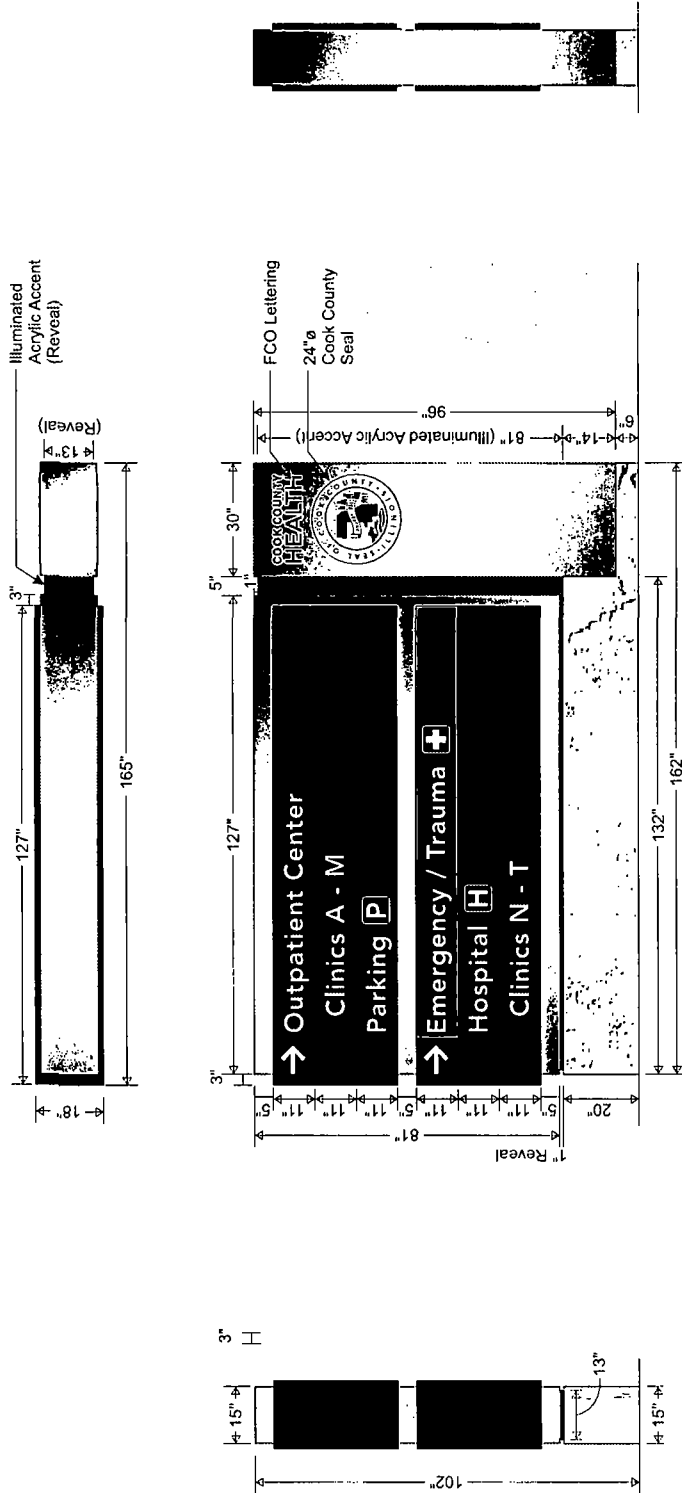

DF Illuminated Monument - Qty: (3 Total)

3/8" = 1"

- Fabricated aluminum tube frame cabinets w/ brushed stainless steel cladding, countersink visible fasteners
- 1/4" Translucent White acrylic illuminated accent (reveal) w/ 1st surface Translucent Light Blue vinyl
- Copy Panel fabricated using 7/12 Retro Body 1600 and Insert Retainer 1666 w/ Access Frame 1690 and brake-formed cover on accessible side, Insert Panel Dividers 1668 between panels to divide copy panels; unit painted to match Dark Blue
- 3/16" Translucent White Polycarb insert panels w/ Plastic Insert Panel Adaptors 1689 applied to top and bottom of back of panels; 1st surface Dark Blue opaque vinyl and knocked out copy, or Red translucent vinyl and knocked out copy as specified
- Internal White LED illumination, power supplies self-contained, electrical brought to within 5' of sign by others
- "COOK COUNTY HEALTH" 1/4" FCO Aluminum lettering, faces and returns painted Black, stud mount
- Seal of Cook County: 1/4" Etched Stainless Steel, horizontal brush finish, w/ Black infill, returns painted Black, stud mount
- 1" Reveal between base of cabinet and concrete foundation, painted Black
- Sign mounted w/ sq steel tubes and poured concrete foundation w/ ledge- refer to engineering drawing for specifications

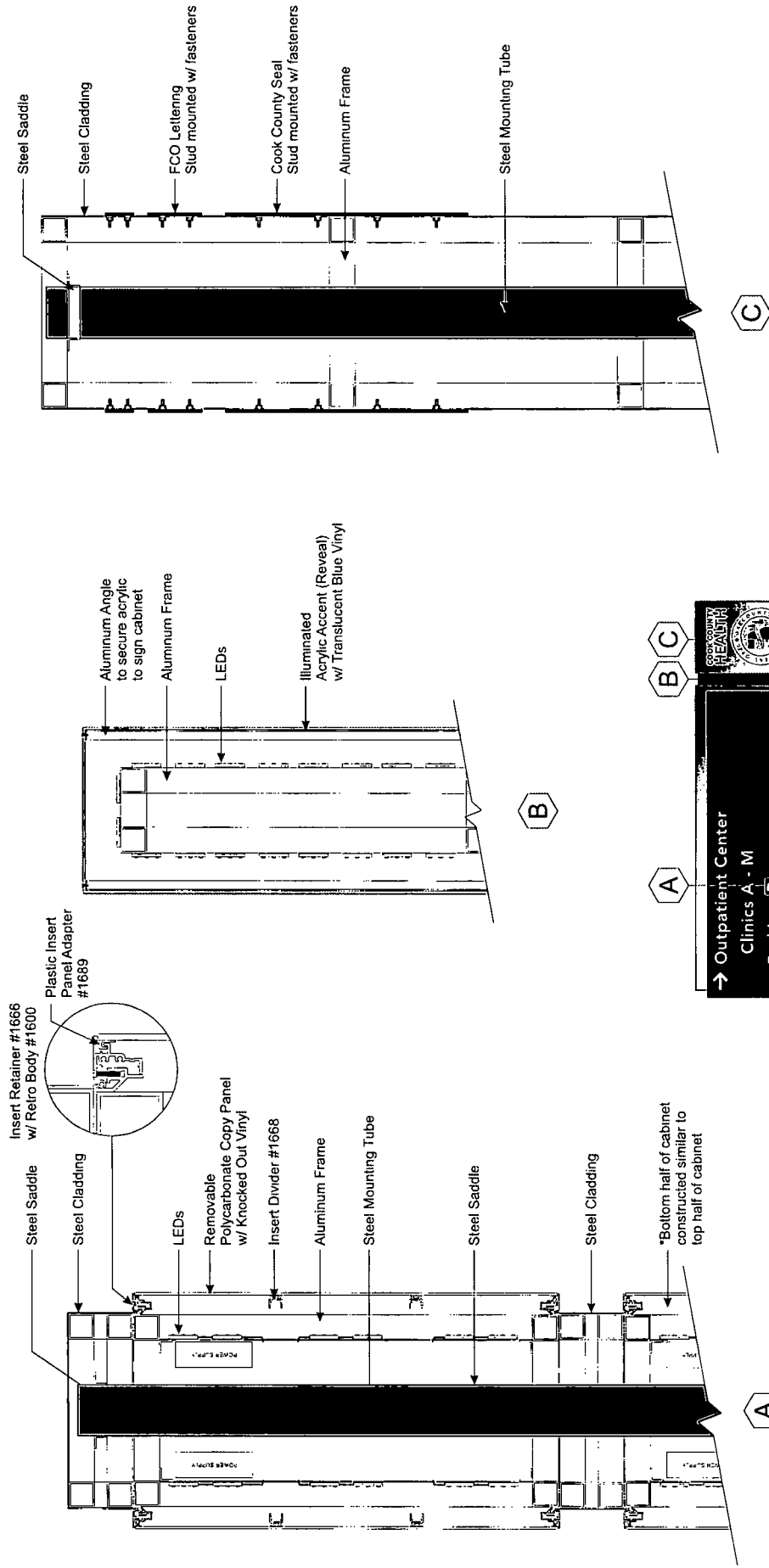
