ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-I in the area bounded by

a line 175 feet north of and parallel to West Hirsch Street;
the alley next east of and parallel to North Rockwell Street;
a line 150 feet north of and parallel to West Hirsch Street;
and North Rockwell Street,

to those of a RM4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

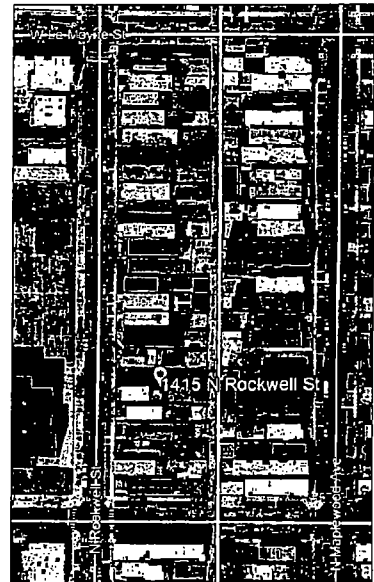
VICINITY MAP

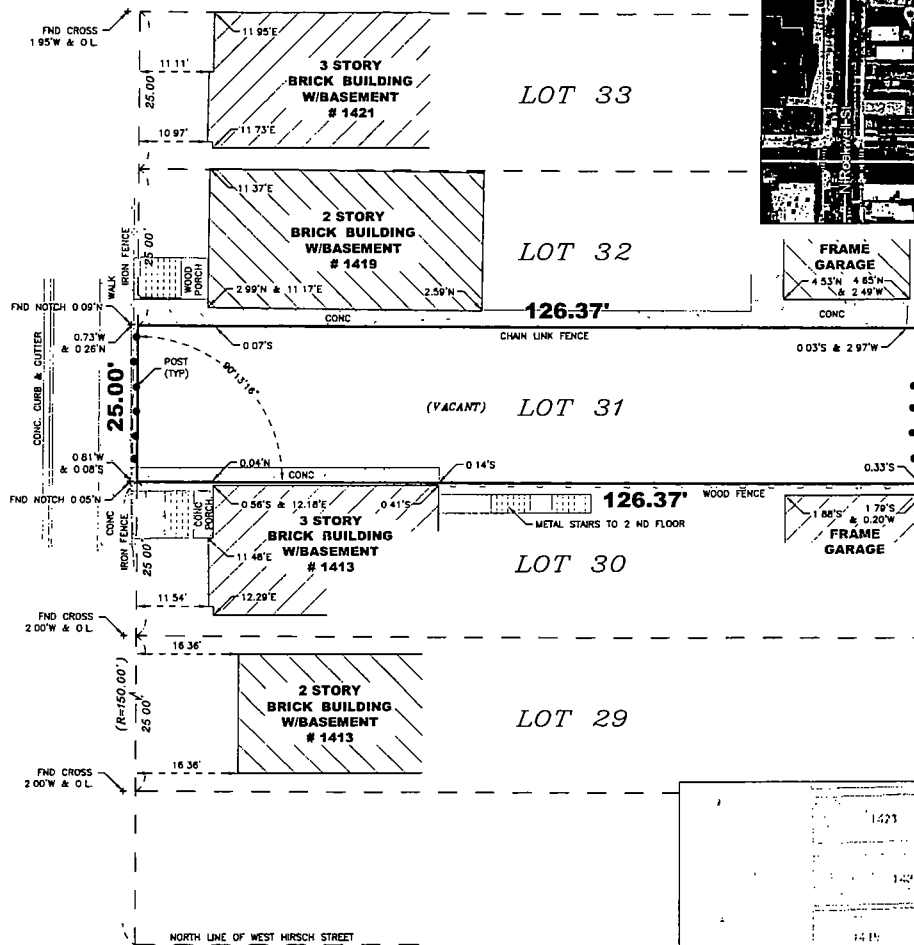
