ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood Commercial District, as shown on Map 7-G in the area bounded by:

A line 50 feet East of and parallel to North Wayne Street; West Wrightwood Avenue; a line 75 feet East of and parallel to North Wayne Street; and the alley next South of and parallel to West Wrightwood Avenue.

To those of **B2-3 Neighborhood Mixed-Use District**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The Application is to change zoning for 1321 West Wrightwood Avenue from C1-1 Neighborhood Commercial District to B2-3, Neighborhood Mixed-Use District. The footprint of the building shall be approximately be 21 feet by 89 feet in size. The building height shall be 48 feet 4 inches high, as defined by City code.


2 FIRST FLOOR PLAN






1 BASEMENT FLOOR PLAN


3 SECOND FLOOR PLAN




4 THIRD FLOOR PLAN




2 FRONT ELEVATION




2 RIGHT SIDE ELEVATION



3 LEFT SIDE ELEVATION




3 REAR ELEVATION
