SECTION 1: That the Chicago Zoning Ordinance be amended by changing all of the M1-2 Limited Manufacturing /Business Park District symbols and indications as shown on Map 18-C in the area bounded by:

East 74th Street; the northern right of way line of the former Baltimore and Ohio railroad; South Cregier Avenue; the alley immediately north of and parallel to East 75th Street; and South East End Avenue

to those of a C1-2 Neighborhood Commercial District and a corresponding use district is hereby established.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and due publication.




