ORDINANCE

BE IT ORDAINED BY THE CITY COUCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential, single-unit (detached house) District symbols and indications as shown on Map No. 1H in the area bounded by a line that is 120 feet west of North Wood Street; the public alley south of & parallel to West Race Ave; -144 feet west of North Wood St: West Race Avenue to those of a RT-4 Residential 2 flat, townhouse and multi-unit district.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.

NARRATIVE DESCRIPTION AND PLANS
FOR THE PROPOSED REZONING AT
1813 WEST RACE STREET

The Application is to change zoning for 1813 West Race Street from RS-3 to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District. The Applicant intends to demolish the existing frame building and construct a Single-Family home. The building height shall be 37 feet 5 inches, as defined by City Zoning Code.

LOT AREA: 2,160 SQUARE FEET

FLOOR AREA RATIO: 1.20

BUILDING AREA: 2,592 SQUARE FEET

DENSITY, LOT AREA per DWELLING UNIT: 2,160 SQUARE FEET






② PROPOSED FIRST FLOOR PLAN




BASEMENT PLAN


② PROPOSED THIRD FLOOR PLAN
